Officer Foy reports... Substantial Battery.....

On 6/6/19 at 0122hrs officers responded to Studz Pub, 6833 W National Ave for a report of a female who had her teeth knocked out by her boyfriend. Investigation revealed Luis E. Bermudez, M/W 06/04/82, was highly intoxicated and upset with his girlfriend, Rebecca S. Ables, F/W 01/14/86, after she wanted to leave the bar because he was cut off from drinking. Bermudez slammed Ables to the ground which resulted in her two front teeth being chipped in half and a small laceration to the inside of her mouth resulting in two stitches. Bermudez was located passed out on the curb nearby Ables' teeth. He denied any knowledge of the altercation and was later transported to CJF. DA set to review on 6/7/19 at 0830hrs.

Officer Foy reports... On 6/15/19 at 0211hrs I observed a physical fight occurring outside of Dingers, 6129 W Beloit Rd. I activated my emergency lights and arrived on scene as numerous people began to run from the scene. I located one male, Mark D. Zittel, M/B [REDACTED], who sustained minor injuries as a result of the fight. CCTV video showed two males approach Zittel after bar close and attack him for unknown reasons. Zittel was highly intoxicated and refused medical attention. Investigation is ongoing for identification of suspects.
