RESOLUTION R-2025-2810**

**RESOLUTION TO ACCEPT THE PROPOSAL OF UNIVERSAL TRUCK
EQUIPMENT FOR FURNISHING AND DELIVERING TWO (2) UNIVERSAL CST
PIN & LOOP 11 FOOT HEAVY TRUCK SNOWPLOW'S FOR \$15,136 EACH, AND
WITH AN ESTIMATED TOTAL SHIPPING/DELIVERY COST OF \$2,000 FOR A
TOTAL NET SUM OF \$32,272**

WHEREAS, the Public Works Sanitation and Street Division is in need of replacing older, 25-year-old Hustling style snowplows with the current Pin & Loop style as older trucks are phased out and newer trucks are purchased with the current Pin & Loop Hitch mounted on them.

WHEREAS, the 2025 approved budget includes \$90,000 for the purchase of two 11' Heavy Truck Plows; and,

WHEREAS, Universal Truck Equipment, has provided pricing utilizing Minnesota DOT Contract# 267382 for the two 2025 Universal CST 11 Foot Heavy Truck Plows for the Public Works Sanitation and Street Division of the City of West Allis; and,

WHEREAS, the Fleet Services Division of the Department of Public Works has determined that this proposal meets all desired specifications, and the proposal received is reasonable; and,

WHEREAS, the Common Council deems it to be in the best interests of the City of West Allis that the proposal of Universal Truck Equipment be accepted.

NOW THEREFORE, be it resolved by the Mayor and Common Council of the City of West Allis that the proposal dated June 9, 2025 submitted by Universal Truck Equipment for furnishing and delivering two (2) new Universal CST Pin & Loop 11 Foot Heavy Truck Snowplows for a total net sum of \$32,272 be and are hereby accepted.

Now, therefore, be it resolved by the Mayor and Common Council of the City of West Allis that the purchase of the above-described items, for an amount of \$32,272, is hereby authorized. Funding for this purchase has been budgeted and is available in the 2025 Capital Improvement Program budget and will be charged to Account Number 352-4218-535.70-03.

Be it further resolved that the Finance Department be and is hereby authorized to enter into a contract for the aforesaid equipment.
