

**CITY OF WEST ALLIS
RESOLUTION R-2023-0546**

**RESOLUTION TO AUTHORIZE THE AGREEMENT BETWEEN THE CITY AND
CDW-G TO PURCHASE 43 EACH NEW DESKTOP COMPUTERS FOR \$21,930.00
AND 20 EACH NEW LAPTOPS WITH DOCKING STATIONS FROM VANGUARD
COMPUTERS FOR \$ 15,640.00, FOR A TOTAL OF \$37,570**

WHEREAS, The City has adopted a 5-year replacement cycle strategy to keep the desktop computers current that City Staff use to perform their daily duties. Rapid advancements in technology are causing some organizations to shorten this to a 3-year replacement strategy but we are staying with 5 years to lower our annual expenses; and

WHEREAS, For the second time we are leveraging our relationship with West Milwaukee to also include their needs in our Request for Proposal. West Allis would like to purchase thirty-six (36) each Desktop Computers and seventeen (17) Laptop computers. West Milwaukee needs to purchase seven (7) new desktops computers and three (3) laptops, which are included in the total requested;

WHEREAS, West Milwaukee will be providing the funding to West Allis for their ten (10) computers; and

WHEREAS, four (4) vendors responded to our RFP and CDW provided the lowest quote for the Lenovo Desktops, and Vanguard provided the lowest quote for the Laptops with Docking Stations; and

NOW THEREFORE, BE IT RESOLVED by the Mayor and Common Council of the City of West Allis that the quote dated July 10th, 2023, for providing 43 Desktop Computers from CDW-G at a total cost of \$21,930 (West Allis = \$18,360) (West Milwaukee = \$3,570), and the quote dated July 12, 2023, for Laptop Computers from Vanguard at a total cost of \$15,640 (West Allis = \$13,294) (West Milwaukee \$ 2,346) be and is hereby accepted. The account where this will be charged to cover the West Allis portion of this purchase (\$31,654) is account # 100-1101-517.51-11.

BE IT FURTHER RESOLVED, that the Information Technology Department be and is hereby authorized to enter a contract for the aforesaid services.


