

**CITY OF WEST ALLIS
RESOLUTION R-2026-5074**

**RESOLUTION GRANTING A PRIVILEGE TO R.D.K.P., LLC FOR PROPERTY
LOCATED AT 6200-06 W. GREENFIELD AVE. (TAX KEY NO. 439-0305-000)**

WHEREAS, R.D.K.P., LLC requests from the City of West Allis a privilege to place an obstruction or excavation beyond a lot line within a highway as allowed by Wis. Stat. § 66.0425, consisting of the obstruction(s) listed on the application (PRV-120) located at 6200-06 W. Greenfield Ave., in the City of West Allis, WI ("Privilege"); and

WHEREAS, by receiving this Privilege, R.D.K.P., LLC assumes primary liability for damages to person or property by reason of the granting of this Privilege, is obligated to remove an obstruction or excavation upon 10 days' notice by the City, and waives the right to contest the validity of Wis. Stat. § 66.0425 or the amount of compensation charged; and

WHEREAS, R.D.K.P., LLC will annually submit to the City proof of insurance consistent with coverage amounts required by the City Attorney's office; and

WHEREAS, the City requires R.D.K.P., LLC file a bond of \$1,000 that runs to the City and to 3rd parties that may be injured and that secures the performance of the conditions specified in this privilege; and

WHEREAS, the holder of this Privilege is not entitled to damages for removal of an obstruction or excavation, and if the holder does not remove the obstruction or excavation upon due notice, it shall be removed at the holder's expense; and

WHEREAS, the cost to remove an obstruction or excavation may be collected from R.D.K.P., LLC by placing the cost upon the owned property as a special tax; and

WHEREAS, third parties whose rights are interfered with by the granting of this Privilege have a right of action against the holder of this Privilege only;

NOW THEREFORE, be it resolved by the Common Council of the City of West Allis, that R.D.K.P., LLC is granted a Privilege to place an obstruction or excavation beyond a lot line within a highway as described in the attached application (PRV-120) and located adjacent to 6200-06 W. Greenfield Ave., subject to any insurance and bonding requirements imposed by the City Attorney.

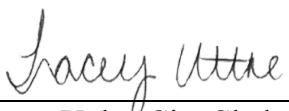

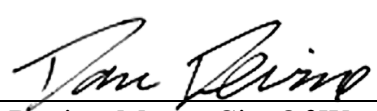
