RE: City Attorney's Report of Claim

Dear Council Members:

The enclosed claim has been referred to this office in accordance with Section 3.05 (6)(a) of the Revised Municipal Code. This office has examined the facts of the claim and the applicable law. Our Opinion regarding liability is as follows:

It is the recommendation of this office that the following claim be denied:

Sharon Borchardt - Amount: \$555.12

This is a claim for vehicle damage that occurred as a result of the claimant striking a pothole in the road on March 3rd, 2008, at South 76th Street and Pierce Avenue in the City of West Allis, WI. The claimant's vehicle needed a new rim, tire and frontend alignment as a result of striking the pothole. The claimant filed a claim against the City on March 5th, 2008, in the amount of \$555.12.

Our investigation into this claim indicated that the City did not have prior knowledge of the pothole prior to it being hit by the claimant. Due to weather conditions, there are an extraordinary amount of potholes this year occurring on streets throughout the City. The Department of Public Works is doing its best to repair potholes as they are discovered. In a case like this, the City is not liable for damages unless it had prior knowledge of the defect in the roadway and failed to repair the same in a reasonable amount of time. These are claims that are best handled by the auto insurance carrier for the claimant.

Based upon the above, it is the recommendation of the City Attorney's Office to deny this claim pursuant to the provisions of Wisconsin Municipal Claim Statute 893.80.




