

INITIAL RESPONSE

On 02/18/14 at approx. 0202hrs. Officers responded to Benno's, 7413 W. Greenfield Ave., for a bar fight involving five people fighting with one possibly armed with a bottle. On arrival Officers located Cecilia S. Cook F/W 10/06/78, April M. Soppa F/W 12/23/82 and Jorge L. Silva M/H 03/14/91 in the rear parking lot. All three parties were highly intoxicated, belligerent with Officers and Jorge was noticeably bleeding from the mouth.

Upon entering the tavern from the rear door, I noticed broken glass all over the floor on the south side of the bar and a damaged bar table (Base came loose from the table top) lying on the ground. Officers also located the intoxicated Tyla J. Oliver F/I and Jeremy D. Oliver M/I 09/24/69 still sitting at the bar. Jeremy's nose was bleeding profusely and there was blood all over his t-shirt.

INITIAL STATEMENT OF JEREMY D. OLIVER

Jeremy stated this evening he was at the tavern with his wife, Tyla J. Oliver F/I 08/20/68 and they were sitting on the south side of the bar. Jeremy stated while they were both drinking and at one point two females (Cecilia and April) and one male party (Jorge) entered the tavern. Jeremy stated once they entered and began drinking they all became extremely obnoxious and disrespectful to the bartender and other patrons. Jeremy advised their behavior consisted of talking loudly, yelling and both females acting racy. Jeremy described the racy behavior as the two females flashing their breasts and also "sucking on each others breasts."

Jeremy stated once the two females began acting racy, Tyla complained to the bartender about their disrespectful behavior. Jeremy advised when Tyla complained, the two females overheard her and began arguing with her. While the three females were arguing back and forth across the bar, the male party began instigating problems between everyone.

Jeremy stated at one point the two females and male began approaching Tyla and Jeremy intervened as he believed they were going to attack her. Jeremy stated he did swing at the male party which resulted in the two fighting, wrestling and rolling around on the ground inside the tavern. Jeremy was unable to provide how many punches he threw and how the bottles were broken. Jeremy denied arming himself with a bottle even though I told him witnesses said he hit the male party over the head with two bottles.

After speaking with Jeremy, he was taken into custody and conveyed to the WAPD.

MEDICAL TREATMENT #1

WAFD responded to assess Jeremy's injuries, however after cleaning him up, he refused any further medical treatment.

ARREST OF APRIL M. SOPPA

After Jeremy was taken into custody, I returned to the rear parking lot and made contact with April. I advised April that she was under arrest for disorderly conduct and she was placed in handcuffs. Since Officer Schweitzer was going to transport her to the station, Corporal McNally and I remained with her until he returned with his squad car. Prior to Officer Schweitzer returning, April was arguing with Corporal McNally and I about why she was arrested. April additionally refused to stand near the rear of the squad car and began pushing her body away from the vehicle. Since April refused to follow directions and was pushing her body away from the squad car, Corporal McNally and I directed her to the ground where she remained until Officer Schweitzer arrived. When Officer Schweitzer arrived, April was secured in the rear of his squad without incident.

BOOKING ROOM BEHAVIOR

While in the booking room, April and Cecilia were belligerent, argumentative and uncooperative with Officers. As a result April was placed in cell #8 while Officers booked the other offenders. While in cell #8, April was kicking/hitting the cell door the entire time.

When Cecilia's booking process was completed and she was free to leave, she demanded a ride home. When Officers told Cecilia that she would have to make her own arrangements for a ride, she began yelling, swearing and threatening

Officers. As a result, Cecilia was placed in cell #4 in order for her to calm down to the point where Officers could release her without further problems.

MEDICAL TREATMENT #2

While booking Jeremy, he began complaining of lung pain and entire body pain. As a result, WAFD responded and at Jeremy's request, he was conveyed to Aurora West Allis Medical Center for treatment.

STATEMENT OF JEREMY D. OLIVER

Once at the hospital and while in ER Room #4 at 0408hrs, I read Jeremy his Miranda warnings as they appear in WAPD Directive 42.016. Jeremy stated he understood his rights and did not wish to answer questions concerning his arrest. The interview was recorded using a WAPD Olympus Digital Voice Recorder #P14. The interview was stored on WAPD Memory Card P14 #2.

The interview ended at 0409hrs. and I placed the memory card in an envelope and secured it in the ID Bureau drawer.

CASE DISPOSITION

All parties were booked, cited and released. A Tavern Report and MORA Report were also completed.

Officer Fletcher reports...

INITIAL CALL

On 02/18/14 at approx. 0202hrs., officer responded to Benno's, 7413 W. Greenfield Ave. for a report of five individuals fighting inside of the bar. After arriving on scene, I made contact with tavern owner Martin J. Weigel M/W 05/09/59 and spoke with him regarding this incident.

WITNESS STATEMENT - MARTIN J. WEIGEL

Weigel advised he is the owner of Benno's, and resides in the upper residence above the tavern. Weigel stated he was sleeping in his bedroom upstairs when the incident began. At approx. 0158hrs., Weigel was awoken by a loud commotion coming from the bar area downstairs. Weigel then walked downstairs and observed 4-5 parties physically fighting at the south end of the bar, outside of the restrooms.

Weigel advised there were three females, and two males involved in the fight, and that the bartender was restraining one of the parties. Weigel advised two of the parties involved were Jeremy D. Oliver M/I 09/24/69 and Tyla J. Oliver F/I 08/20/68, whom he recognized as a frequent customers. Weigel described the other male party involved as a "skinnier" W/M who had blood on his face. Weigel was unable to provide any further description for any of the parties involved, and stated that the whole incident "just happened so fast."

After Weigel observed the parties fighting, he observed Jeremy and Tyla attempting to calm the other three parties down. Weigel stated the parties refused to calm down and continued to scream at Jeremy and Tyla. After Weigel observed that the argument was not calming down, he called 911 from the bar. Weigel described the physical fighting as "wrestling," and advised he did not remember observing anyone get hit with a bottle. Shortly after Weigel called 911, he observed the W/M and two females that were involved walk out of the rear door of the tayern as officers arrived.

WITNESS STATEMENT - DONALD R. KOSIBOSKI

While inside of the tavern, I also spoke with Donald R. Kosiboski, who witnessed the altercation inside of the bar. Donald advised he was at the tavern since 2300hrs. and was seated at the south end of the bar when the incident occurred. approx. 2330hrs., and were seated next to him at the south end of the bar. At approx. 0100hrs., Donald advised a M/W and two F/H's entered the tavern and sat approx. half way down the bar. Donald stated he did not know who these parties were, but that they were extremely intoxicated.

Donald stated there was no problems between Jeremy, Tyla, or the other three parties for approx. the next hour. Donald advised the two females that entered the bar with the M/W were acting belligerent, and were exposing themselves to other patrons inside of the bar. Other than the three parties being highly intoxicated, Donald advised they did not cause any problems up until the altercation. At approx. 0200hrs,. Donald advised the two females and M/W got up to leave the bar. Before leaving the bar, the M/W walked towards Donald, Jeremy, and Tyla at the south end of the bar. Donald could not describe what happened next, other than "they just started going at it." Within approx. five seconds, Donald advised Jeremy and the M/W began physically fighting and eventually wrestled each other down to the ground. Donald advised Tyla and the other two females also began fighting.

After the fight began, Donald advised he stepped out of the way because he did not want to get involved. The parties continued to physically fight on the ground for approx. two minutes. Donald could not remember if any of the parties struck one another during the altercation, and stated the whole incident just "happened so fast." However, Donald advised he remembered seeing the M/W swing a beer bottle at Jeremy's head. Donald was unsure if Jeremy was struck by the bottle. After approx. two minutes, the M/W and two females separated from Jeremy and Tyla and walked out of the rear door of the tavern. Officers arrived on scene shortly after.

OFFICER OBSERVATIONS

While on scene, Officer Said and I observed the surveillance footage of the altercation. While watching the footage, I observed the M/W, later identified as Jorge L. Silva M/H 03/14/91 confront Jeremy at the end of the bar. Approx. five seconds after the Jorge approached Jeremy, Jeremy appeared to strike Jorge in the face with a beer bottle. Jeremy and Jorge then began physically fighting on the ground. I also observed that Donald had his back to Jorge and Jeremy when the incident began, making it impossible for him to see who was struck with the beer bottle.

TRANSPORT OF JEREMY D. OLIVER

Based on the on-scene investigation, Jeremy was placed under arrest for battery. I placed Jeremy in handcuffs and transported him back to the WAPD for booking. Jeremy was turned over to Officer Molthen for booking.

NARRATIVE

INITIAL OBSERVATIONS

On 2/18/14 at approximately 0202 hrs, Squad 321 responded to the tavern Benno's, 7413 W Greenfield Ave for a report of a fight involving a male with a beer bottle. Upon arrival I entered the tavern and inside the main room (where the bar was located) I observed a table broken and thrown to the ground, broken pieces of a Spotted Cow beer bottle near the bathrooms and a male in a white long sleeve t-shirt with multiple spots of blood on it. I also observed a male black in a grey sweat shirt with blood on his hands, who was later identified as Justin C. Powell, asking if he could enter the bathroom and clean his hands. I allowed Powell to wash his hands and began questioning him concerning what he observed of the incident.

ON SCENE WITNESS STATEMENTS - JUSTIN C. POWELL (M/B, 2/3/78)

Justin C. Powell stated he came to the tavern at approximately 10 pm, 2/17/14and was seated at the bar when he met a male and female couple who claimed to be Native Americans (later identified and further referred to as: Jeremy D. Oliver m/I, 9-24-69; and Tyla J. Oliver f/I 8-20-68). Powell said another group of three individuals, two females and a male (later identified as and further referred to as: Jorge L. Silva Jr. m/w, 3-14-91; Cecilia S. Cook f/w, 10-6-78; and April M. Soppa f/w, 12-23-82) came into the bar and sat further down the bar. Powell observed everyone interacting and talking back and forth for sometime and Powell said there was not any indication that they would fight.

Powell stated at some point Soppa and Cook began complaining that they did not like the way Tyla was looking at them. Soppa and Cook began telling the Tyla to stop looking at them like that and Silva began to tell Tyla to

Powell observed Silva walk to where Jeremy was seated at the bar and Powell said he was looking the other way when they began to fight. Powell turned around and found the two were wrestling on the ground. Powell stated shortly after he observed all the females, Tyla, Cook and Soppa also fighting on the ground. Powell began assisting in pulling apart all those interacting in the fight until police arrival.

Powell did not have any signs of injury or any signs that led me to believe he was involved in a physical altercation. Powell did have a small amount of blood on his hands, which was consistent with his statements about pulling the individuals involved apart from each other.

VIDEO

While on scene I observed video from the tavern surveillance system. The following is a synopsis of the video's recording involving the incident being investigated:

The video showed the section of the bar where Cook, Soppa and Silva were all seated. During the video all three are seen speaking in the direction where Jeremy and Tyla were both seated in an aggressive manner, pointing and appearing to be yelling (the portion of the room where Jeremy and Tyla were seated is not visible from the camera's angle). The bartender then comes around the bar and appears to be presenting the bills to Cook, Soppa and Silva and appears to be asking them to leave and act as a buffer between the two groups (the two groups being: Silva, Cook and Soppa as one group; Jeremy and Tyla, the second). Powell is also visible and appears to be seated next to Soppa, though he does not appear involved in the yelling.

After Cook, Soppa and Silva all appear to have signed their bills, Silva grabs his jacket and walks in the direction of where Jeremy and Tyla were seated. He continues to speak in this direction. While Silva is standing close to the Women's bathroom near the end of the bar where Jeremy and Tyla were seated, it can be seen that Jeremy comes into the view of the camera, appearing to swing a beer bottle at the head of Silva. It appears that liquid comes forth from the bottle, but I was not able to discern if the bottle broke during this action.

Directly after the bottle is thrown / swung at Silva both Silva and Jeremy begin to grab each other and quickly move out of the view of the camera. Shortly after they leave view of the camera both Cook and Soppa both rush to same portion of the bar room, out of the view of the camera. INITIAL CALL

On 02/18/14, at approximately 0202 hrs., Officers responded to Benno's, located at 7413 W. Greenfield Ave. for a report of a physical fight.

CONTACT WITH NATHAN T. LEE

Upon arrival, I made contact with employee, Nathan T. Lee, M/W, 04/02/79, who was the bartender on duty during the incident. Lee stated three individuals later identified as April M. Soppa, F/W, 12/23/82, Cecilia S. Cook, F/W, 10/06/78, and Jorge L. Silva, M/W, 03/14/91, walked into the bar at approximately 0100 hrs. Lee called "Last Call" and Cook, Soppa, and Silva ordered more beverages. Lee did not serve them because he felt they had too much to drink. Lee stated Cook and Soppa were also acting inappropriately and he was attempting to get them as well as Silva to leave.

Lee stated he overheard Soppa "mouthing off" at Jeremy D. Oliver, M/I, 09/24/69. Silva then proceeded to say "racial slurs" towards Oliver. Lee overheard either Silva or Oliver state, "Let's take this outside". Lee observed Silva and Oliver move towards each other and fall into a bar table; landing on the ground. Lee stated the altercation lasted approximately 5-10 minutes. Lee was unable to determine who started the fight. Lee stated he believed he then saw Cook kick Oliver in the head.

Lee did not see the individual who picked up the beer bottle and hit Oliver in the head. Lee stated he attempted to break up the fight but was unable to. Lee observed Cook, Silva and Soppa exit the rear of the bar before Officers

Silva Jr. (m/w, 3/14/91) stepped out of the vehicle.

STATEMENT BY JORGE L. SILVA JR.-OFFENDER

Jorge L. Silva Jr., (m/w, 3/14/91) had exited the vehicle and approached me. As he was walking towards me, I observed a large amount of blood coming from his mouth and his upper lip appeared to be cut.

Jorge provided me with a WI-ID card for his identification. Jorge stated that he was in Benno's bar with his cousin and her friend. Jorge decided to go to the bathroom and as he exited the bathroom, he observed his cousin and her friend on the ground being assaulted by 2 males. Jorge decided to step in and attempt to break the fight up. As Jorge attempted to break up the altercation, he was hit in the mouth with a beer bottle by a male Indian with long hair and dark clothing on. The bottle shattered after it made contact with his face. After being struck in the face, Jorge continued to try and break up the fight. Seconds later, he was struck in the back of the head with another beer bottle. This bottle however, did not break.

I asked Jorge if there were any problems throughout the night between him and the person that hit him in the face with the bottle and he stated, "no." Jorge said that he, his cousin, and her friend were out just having a good time. Jorge does not know what started the fight and did not think that there were any problems between anyone in the bar. Jorge thought the person that hit him was jealous of how much money they were spending.

At no time was Jorge involved in a fight or physical altercation. He did not get into a fight with anyone and was merely trying to break it up.

Jorge described the pain in his head and mouth as a 7 out of 10. Based on Jorge's injury, he was transported to Aurora West Allis Medical Center for treatment.

fighting, the females also jumped in and struck Jeremy. One of the females then turned and struck Tyla in the face and they started fighting on the ground. Tyla stated she was punched and kicked in a body and face. She also threw punches to defend herself.

During the fight, the owner of Benno's walked in and Tyla told him to call the police. The fight then broke up Jorge and the two females left out the back door.

ARREST OF TYLA

After speaking with other officers, Tyla was involved in the fight and was arrested for disorderly conduct. PO Carlson conveyed Tyla back to the WAPD. At the WAPD Tyla was booked and given municipal citation M140007951 for disorderly conduct.

MIRANDA INTERVIEW

I escorted Tyla to booking interview room A where I activated WAPD digital recorder using memory card 18-2. I read Tyla her Miranda Warning as it appears in WAPD Dir. 42.016. After reading and understanding these rights, Tyla agreed to speak with me. The following is a synopsis of my interview with Tyla:

While under Miranda Tyla stated her and her husband Jeremy arrived at Benno's at approx. 0015hrs. and were there for approx. a half hour before a male and two females came into the bar. They were noticeably intoxicated prior to being served at Bennos. As the two women sat at the bar, they began fondling themselves and showing their breasts. Tyla didn't like this and told the bartender.

A short time later Tyla was confronted by the blonde female who told her "Fuck you bitch if you are offended." While the blonde female confronted Tyla, the male confronted Jeremy and started fighting with him. Both females also jumped in to fight with Jeremy and Tyla attempted to pull the females off of Jeremy. One of the females turned around and struck Tyla in the face and they were fighting on the ground. During the fight, Tyla was punched in the face and body as well as kicked in the body.

After completing the interview, I secured memory card 18-2 and later placed it into the FTSB drawer.
