An Ordinance to Establish Parking Restrictions on Both Sides of the 1000, 1100 and 1200 Blocks of S. 56 Street.

PART I. Pursuant to Section 10.10 of the Revised Municipal Code, the following parking restriction is established:

Street: S. 56 St.

Block: 1000, 1100 and 1200

Side: Both

Restriction: 2 Hour Parking 8:00 AM to 5:00 PM, Monday-Friday

PART II. All ordinances or parts of ordinances contravening the provisions of this ordinance are hereby repealed.

PART III. This ordinance shall take effect and be in force from and after its passage and publication.
