Police report incidents involving licensed businesses:

Incident reports:

On the above date and time officers responded to Yesteryears for a report of parties being assaulted inside of the tavern. One of the parties also had two gold chains stolen by one of the offenders. The bartender was the complainant who called the department. This appeared to be an argument over a pool game between five parties.
