## CITY OF WEST ALLIS RESOLUTION R-2025-5677

RESOLUTION AUTHORIZING THE CITY ENGINEER TO ENTER INTO AN AGREEMENT FOR REIMBURSEMENT FROM MMSD TO FUND THE DISCONNECTION OF FOUNDATION DRAINS AND SANITARY LATERAL REHABILITATIONS ON 2025 STREET RECONSTRUCTIONS IN AN AMOUNT NOT TO EXCEED \$146,000

**WHEREAS**, Wisconsin Statutes Section 66.0301 authorizes any municipality to enter into an intergovernmental cooperation agreement with another municipality for the furnishing of services; and

WHEREAS, during wet weather events, storm water enters private lateral sewers through defective pipes and leaky joints and connections ("infiltration") and storm water also enters private lateral sewers from foundation drains, improper connections, and other sources ("inflow"); infiltration and inflow increase the amount of wastewater that the Milwaukee Metropolitan Sewerage District (MMSD) must collect and treat; and

**WHEREAS,** MMSD has made available to its communities a source of funding to reduce infiltration and inflow from private property, and

**WHEREAS**, the City of West Allis will enter into a contract to perform work to reduce infiltration and inflow based on MMSD's funding proposal.

**NOW THEREFORE,** be it resolved by the Mayor and Common Council of the City of West Allis that the City Engineer is authorized and directed to sign the funding agreement titled Private Property Infiltration and Inflow Reduction M10005WE05 with MMSD.

**BE IT FURTHER RESOLVED** that the City Engineer is authorized to make any non-substantive changes to the funding agreement to effectuate its intent and to prepare and deliver any other documents necessary to complete the approved agreement.
