D. NEW AND PREVIOUS MATTERS

2. [25-0025](#) Consideration relative to the Financial Report for the period ending 6/25/25 presented by Devan Gracyalny, Vice Chair/Treasurer.

Mr. Gracyalny reported there was no change from last month's financial report.

3. [25-0026](#) Report from the West Allis Historical Society.

Mr. Gracyalny reported on recent technology upgrades at the historical Society, including the installation of new LED lights. He also shared that the Historical Society is exploring the sponsorship of admission tickets for various school athletic events.
