3. Vacancy Effective: October 16, 2009
4. Vacancy Reason: retirement
5. a. What are the specific work responsibilities of the position?

The employee in this position performs skilled work at the journeyman level including the installation, maintenance, inspection, and repair of the City's electrical system. The electrical system includes street lighting, lighting in parks and parking lots, lighting in public buildings and a traffic control system. Certification as a Master Electrician with the State of Wisconsin and possession of an Electrical Maintenance License or Electrical Contractor's License is required.

- b. How many other such positions exist in this Department?
6. What are the reasons why the position must be filled?

Installation of new and maintenance of City's existing electrical systems.

7. What will be the impacts on service functions if the position were not filled?

- a. Service to the public

The maintenance of the various electrical systems would be reduced increasing complaints from the public. Lighting circuits out have the potential of increasing crime while increased traffic light failures will result in increased accidents.

- b. Service to staff

There would be increased complaints from City employees and citizens affected by lack of repairs and maintenance to City's electrical system.
