#### 1. REVIEW OF NEW LEGISLATION

AB348 PRIVATE ROADS IN MOBILE HOME PARKS

AB349 ACCESS TO PROPERTY OWNER'S NAME WHEN TAX ROLL IS

#### 2. REVIEW OF REFERRED LEGISLATION

AB316/ RECODIFICATION OF EMERGENCY MANAGEMENT LAW

SB226 FAVOR, because the bill would positively address emergency planning and

management related to powers and duties, disaster assistance, response teams, and

management compacts.

#### 2. REVIEW OF REFERRED LEGISLATION Cont'd.

AB313 LICENSURE FEE FOR AN EMERGENCY MEDICAL TECHNICIAN OPPOSE, because the bill would create an unequal treatment with respect to EMT license fees.

### AB319 REGIONAL STRUCTURAL COLLAPSE TEAMS AND GRANTING

SB229 RULE-MAKING AUTHORITY

FAVOR, because the bill would help determine rules for reimbursement of structural collapse teams.

# AB308 POLICE ESCORTS AND VEHICLE RIGHTS-OF-WAY RELATED TO ESCORTED VEHICLES AND PROVIDING A PENALTY No position.

SB224 PROCESS FOR DISCONTINUING STREETS No position.

### SB234/ CONSUMPTION OF ALCOHOL BEVERAGES IN PUBLIC PLACES AB335 OPPOSE, because the bill would allow the unlicensed and unregulated serving of

alcohol at colleges, thus making underage drinking easier.

# AB331 INSURANCE COVERAGE OF ORTHOTIC AND PROSTHETIC DEVICES AND SERVICES

OPPOSE, because the bill would be another health insurance State mandate, thus taking it away from local decision-making control.

## AB337 PAYMENT OF EMPLOYEE REQUIRED CONTRIBUTIONS UNDER THE WISCONSIN RETIREMENT SYSTEM

FAVOR, because the bill would significantly reduce City expenditures for WRS employee contributions.

## AB330 REQUIREMENTS FOR ELECTORS WHO VOTE BY ABSENTTE BALLOT

OPPOSE, because the bill would allow for non-witnessed absentee balloting and remove desirable voting procedures.
