E. CITIZEN PARTICIPATION

Robert Braun, 2160 S. 86 St., President of Stop the Violence, commented on the West Allis-West Milwaukee School Board and their decision in regard to bathrooms within the schools; spoke on the Muslim religion, Mosques, terrorism, and announced a meeting at South Milwaukee City Hall.

Violet Braun, 2160 S. 86 St., wished the Council a wonderful summer. Mrs. Braun opposed the bathroom bill to be taken up in the schools; and is against Sharia Law. Mrs. Braun supports the Constitution and loves America.

Alfred Courturier, 2801 S. 72 St., spoke about the bump out petition passed around the residents who live on S. 72 Street from W. Beloit Road to W. Kinnickinnic River Parkway that are opposed to the bump outs. Mr. Courturier addressed speeding reports. Mr. Courturier stated it is the opinion of the residents that the bump outs will narrow the road. Mr. Courturier asked about assessments and the size of the street.

Gail Bachmann, 2881 S. 72 St., is opposed to the bump outs and how the bump outs will affect her getting in and out of her driveway and the street itself; spoke on the cost of the project and asked how the snow will impact the effectiveness of the bump outs.

Chet Parker, 7140 W. Greenfield Avenue, President of the West Allis Business Downtown Improvement District, spoke about the West Allis Ala Carte and on how this event gives back to the Community. The following organizations that benefited from this year's event are: Community Alliance Against Drugs \$1900, Christmas parade \$3922, Fire Department \$737, Police Department Community Services \$737, and monies raised from the Animal Avenue the following benefited: No Kill Shelters in the City \$400, 400 pounds of pet food, 100 pounds of toys, beds, and cleaning supplies, plus Mr. Parker plans to expand the giving to other groups.

Chuck Bachmann, 2881 S. 72 St., is opposed to the bump outs, doubts if the bump outs will deter speeders, concerned about access to the street, and safety concerns regarding traffic accidents.

Dean Francis, 6501 W. Greenfield Ave., is opposed to a liquor license ever being issued to the premise of 6500 W. Greenfield Avenue because people are treated terribly, litter in the area, and nighttime disruptions.

Gary Williams, 2908 S. 72 Street, is opposed to the bump out because of safety concerns of motorcycles. Mr. Williams suggested closing the road by Kinnickinnic River Parkway to reduce speeding. Mr. Williams asked for clarification on the scope of the project, if they doing both the roads and the driveway approach, and the cost. Mr. Williams compared the streets of Wauwatosa to West Allis.

Mark Vicena, 1338 S. 65 Street, is opposed to a liquor license being issued to the 6500 Restaurant and Bar stating in the past there has been selling of heroin, illegal alcohol purchases, and illegal gambling at this location plus it is a nuisance property.

Sheryl Cruz, 1344 S. 65 Street, is opposed to a liquor license being issued to the premises of 6500 W. Greenfield Avenue commenting that in the past this location has been noisy and a nuisance property.
