As you are aware, whenever a vacancy comes up, we evaluate the need for the position along with what other options we may have. With Tom Harmatys taking over as Assistant Director of Public Works, we have been looking at a number of possibilities with his old job as Superintendent of Building & Sign including combining positions.

After talking with members of my staff, along with other appropriate City departments, I have appointed Douglas Bartels to a six month trial as Superintendent of Build & Sign and Inventory Services (title of position may change along with responsibilies during the six month trial period). Doug was supervisor of the Inventory Service Division and will continue to supervise this Division along with Building and Sign. This appointment was effective Monday, July 19th.
