



Please take notice that the City of West Allis enacted on 9/1/2020:

Ordinance No. O-2020-0040, Ordinance to amend the City of West Allis salary schedule relating to the creation of the position of Tradesperson-Carpenter.

Ordinance No. O-2020-0037, Ordinance to establish parking restrictions on the south side of W. Greenfield Ave., from S. 60 St. to 120 feet east of 60 St.
