


I would appreciate it if the Common Council would approve the Special Use Permit for the proposed placement of AT&T telephone equipment cabinets. I believe these cabinets are necessary for AT&T to bring the U-verse service to West Allis. I look forward to the opportunity of AT&T to compete with Time Warner, which could possibly reduce my cost of cable.

I don't think it is the City of West Allis's entitlement to limit my access to a product that is offered to residents of other cities. I realize one concern of the cabinets is that they might not be pleasant to look at. However, if the West Allis Administration was truly concerned with the unattractiveness of the West Allis neighborhoods, they would do something about the hideous maintenance of the Kmart shopping center on 70th and Greenfield.

I know numerous individuals from a variety of other cities who have U-verse and the equipment cabinets in their neighborhoods.
