#### D. MATTERS FOR DISCUSSION/ACTION

2. [24-0710](#) Appeal of Dangerous Dog Order for Bucky by Veronica Ortega Ramirez issued on November 24th, 2024, at 1003 S. 100th St. (AARB-22)

Clark moved to uphold the Dangerous Dog order without amendments for the dog "Bucky" owned by Veronica Ortega Ramirez, Ald. Weigel seconded, motion carried.

3. [24-0711](#) Appeal of Prohibited Dog Order for Dash by Janessa James issued on December 4th, 2024, at 1942 S. 69th St. (AARB-23)

Clark motioned to uphold the prohibited animal order, Ald. Weigel seconded.

Clark moved to withdraw his motion. Clark motioned to amend the order from a prohibited animal to a dangerous animal order for Dash with the mandatory restrictions. In addition, Dash must complete training sessions and provide proof to the Police Department within 120 days of the hearing. Ald. Weigel seconded, motion carried.
