The following is a summary of reported incidents involving licensed businesses, including reported tavern violations and calls for police service during the month of May.

Incident reports:

Case #15-18611, 05/03/2015, 0023 hrs: 7408 W. Walker St – Guzzlers

On 05/03/2015, Officers responded to Guzzlers for a report of a male being restrained by several individuals. Investigation revealed an intoxicated male party was causing a disturbance and punched other people in the face. After he physically assaulted these two individuals, he was taken to the ground and restrained by several people. He was arrested and cited for Disorderly Conduct.

Case #15-18631, 05/03/2015, 0224 hrs: 9442 W. National Av – Heartbreakers

On 05/03/2015, an Officer observed two vehicles parked in the middle of the street and noticed a disturbance outside of Heartbreakers. Contact was made with a highly intoxicated party, who according to Security staff from Heartbreakers, was asked several times to leave and was refusing. This party was arrested and issued a citation for Disorderly Conduct.

Case #15-21205, 05/17/2015, 2336 hrs: 7211 W. Greenfield Av – Seven West Bistro

On 05/17/2015, Officers responded to Seven West Bistro for a report of 15-20 subjects displaying weapons and jumping on vehicles. Officers made contact with four uncooperative females in a vehicle behind the tavern. The juvenile female driver refused to identify herself, exited the vehicle, and began actively fighting with Officers while being taken into custody. As Officers attempted to take the driver into custody, a juvenile female and adult female exited the

vehicle and also began fighting with Officers. All three parties were taken into custody and cited for Disorderly Conduct.

Case #15-21697, 05/21/2015, 0152 hrs: 8824 W Becher St - The Walleye Saloon

On 05/21/2015, Officers responded to The Walleye Saloon for a report of a suspicious person. Officers met with a female and male party. Investigation revealed an open Milwaukee County Court Case, which showed the male to have no contact with the female party and absolute sobriety. The male party had a PBT reading of .200BrAc. The female party was also highly intoxicated. She was arrested on a warrant from Oak Creek PD and he was arrested for Bail Jumping and Knowingly Violating a Domestic Abuse Order.

Case #15-23032, 05/29/2015, 1939 hrs: 9141 W. National Av – Oval Bar

On 05/29/20015, Officers responded to the Oval Bar for a report of a car swerving and almost hitting the caller and another vehicle. Officers made contact with the party in the parking lot of the Oval Bar, where he admitted to having a couple sips of one beer inside the bar. He was arrested for OWI 2nd and Operating after Revocation. The bartender also admitted to serving him one beer.
