The following is a summary of reported incidents involving licensed businesses, including reported tavern violations and calls for police service during the month of April, 2022;

**INCIDENT REPORTS:**

**CASE # 22-010951 – 04/03/22 – 2140hrs. – Red White & Brews – 7127 W National Ave**

**CALLER: ERIC G. MILLAR**

**Cpl. Shultz Reports:**

On 04/03/22 at approximately 2140 hours, officers were dispatched to 7127 W National Ave, Red White and Brews, for a report of a fight. Investigation revealed there was a large disturbance within the bar involving fighting between several parties. Kyle R. Armstrong [REDACTED], Mariah R. Armstrong [REDACTED], Ashley E. Condecon-Acker [REDACTED] all received disorderly conduct citations. Alyssa M. Balboa [REDACTED] received a battery citation. Municipal court date set for 06/13/22.

**CASE #22-010973 – 04/04/22 – 0214hrs. – Kipps Inn – 837 S 108 St**

**Officer Sandvick Reports:**

On 04/04/2022 at 0214hrs, officers responded to 837 S 108 St to investigate a vandalism. Upon arrival, officers spoke with Katie M Newbery ([REDACTED]). Katie stated her car had been keyed. She suspected a male that was drinking at the bar because he was angry when he left around 0130hrs. Katie advised officers there were five cars in total that were keyed. Follow-up was conducted and James R. Haase ([REDACTED]) was identified as the suspect in the incidents. Haase was issued citations for his involvement.

**CASE #22-011674 – 04/09/22 – 1447hrs. – Dog House – 1641 S 68 St**

**Officer Kossow Reports:**

On 04/09/2022 at approximately 1447 hrs, officers responded to The Dog House, 1641 S. 68<sup>th</sup> St., for a report of individuals fighting and arguing inside of the bar. The bartender, Lynn A. Alioto ([REDACTED]), stated a male, later identified as Corey J. Frank ([REDACTED]), was arguing with other patrons, yelling racial slurs, and causing a disturbance. Corey left the Dog House with an outstanding tab of \$23.00 worth of alcoholic beverages that he consumed. Corey was located at Dopps and taken into custody for local disorderly conduct and fraud on a restaurant. Corey had bloodshot and glassy eyes, a strong odor of intoxicants emanating from his breath, and provided a PBT reading of .209. Corey has an open Waukesha County Felony case #2021CF001846 for OWI 3<sup>rd</sup> causing injury and hit and run causing injury. A few of Corey's bail conditions for that case are absolute sobriety, not to possess or consume alcohol, and not to enter premises that primarily sell alcoholic beverages. Corey was then arrested for felony bail jumping for violating his conditions. Corey was transported to CJF and the Milwaukee County District Attorney's Office will review this case on 04/11/2022 at 0830 hrs.

**CASE #22-011755 – 04/10/22 – 0215hrs. – El Sagitario – 907 S 84 St**

**Officer Santa Cruz Medina Reports:**

On 04/10/22 at 0215 hrs, officers responded to El Sagitario, 907 S 84 St, for a weapons call. Investigation revealed that several parties got into a physical altercation at the bar and security had to deploy OC spray to break it up. During the altercation, Jairo L. Guardado Escobar ([REDACTED]) displayed a black airsoft pistol. Jairo was arrested for DC – While Armed. Jairo was booked, cited, and released.

Chasenah was conveyed to Froedtert Hospital to receive medical treatment. Officers identified the suspect in this incident to be Shane L Saenz-[REDACTED]. Chasenah later spoke with officers, who did not wish to pursue any charges.

On 04/22/2022 at 1119hrs, Officers responded to 8028 W National Ave, JC's Pub, for a check on the welfare in regard to a women being in the bar, with 2 kids, not acting right. Officers arrived on scene and made contact with the bartender who stated the women had been in the bathroom with her two children for 20 minutes. Officers checked on the female who was later identified as Samantha J Slater [REDACTED] who was passed out in the stall with her two children. Slater refused to identify herself and was causing a scene in the bar. Slater was clearly under the influence of a narcotic and could not care for her children. Slater was taken into custody which she resisted. CPS was called. Slater had warrants for her arrest through Waukesha. She was transported to Waukesha and the additional charges referred to the DA's Office for Child Neglect and Resisting.

**CASE #22-013712 – 04/24/22 – 0102hrs. – Rosco's – 6711 W Beloit Rd**

**Cpl. Sayeg Reports:**

On 04/24/22 at approximately 0102 hours I was dispatched to Rosco's, 6711 W Beloit Road, for a bar fight. Investigation determined Steven L Schaff [REDACTED] got into a physical altercation with Richard L Tompkins [REDACTED] after being asked to leave the bar. Schaff assaulted Tompkins and was arrested for municipal DC-Battery. Schaff was issued citations on scene and given a courtesy ride home.

Chelsea stated she was bartending Eckbar, 7408 W. Walker St., and when she was not ready to leave when Isiah pushed her and punched her in the face. Chelsea advised it took her this long to report this incident due to her being so scared of him. An attempt was made to get Isiah into custody, but was unsuccessful. Isiah was booked out of custody for DV/DC, and this incident is scheduled for review on 04/27/22.

Tavern compliance squads check randomly selected taverns in the City of West Allis for miscellaneous tavern violations such as license violations.

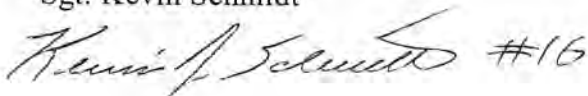
*Officers trained in Class B tavern compliance checks performed 16 tavern checks at randomly selected taverns in the month of April, 2022.*
