

**CITY OF WEST ALLIS
RESOLUTION R-2026-5442**

**RESOLUTION AUTHORIZING THE CONTINUATION OF THE HUMANA
MEDICARE ADVANTAGE PLAN FOR MEDICARE-ELIGIBLE RETIREES FROM
JANUARY 1, 2027 TO DECEMBER 31, 2027**

WHEREAS, the City originally began providing a Medicare Advantage Plan as a total replacement for Medicare eligible retirees on July 1, 2018 based on the comprehensive benefit plan offerings, along with a significant reduction in premium costs for retirees and the City's retiree health insurance obligations, including the City's Other Post-Employment Benefits (OPEB) liability; and

WHEREAS, the current agreement with Humana for the Medicare Advantage Plan expires on December 31, 2026, and the City has received a renewal package for the period of January 1, 2027 through December 31, 2027; and

WHEREAS, with the assistance of the City's employee benefits consultant, USI Insurance Services, City staff reviewed the renewal package and recommends renewal of the Humana Medicare Advantage Plan using Humana's decoupled medical and prescription drug plan structure, which maintains the City's current Medicare Advantage benefit package while reducing the City's monthly premium from \$512.13 per member per month in 2026 to \$493.35 per member per month in 2027; and

WHEREAS, the Common Council deems it to be in the best interest of the City of West Allis to renew the Humana Medicare Advantage Plan for the period of January 1, 2027 through December 31, 2027.

NOW THEREFORE, be it resolved by the Common Council of the City of West Allis that the 2027 Humana Medicare Advantage Plan renewal package is accepted, with funding for this agreement to be provided in the Health Insurance Fund.

BE IT FURTHER RESOLVED that the City Administrator or their designee is authorized and directed to execute the renewal agreement, plan documents, and such other documents as may be necessary for the implementation of the 2027 Humana Medicare Advantage Plan.

BE IT FURTHER RESOLVED that the City Attorney is authorized to make any non-substantive changes to the approved documents to effectuate their intent and to prepare and deliver any other documents necessary to complete the approved transaction.
