two girls were working under the WI WINS program for the State of Wisconsin. Delaney and Analise were brought in by Wendy Smith Ozug, who works with WI-WINS. Both Delaney and Analise had the permission of their parents to assist me in the tobacco compliance check.

Before Delaney, Analise Wendy and I went on the road I instructed the girls to go into each store I had selected and attempt to purchase a tobacco product. Both Delaney and Analise were provided buy money by Wendy for the the compliance check. I advised both they could not have any identification on them at the time of the check and were instructed to tell their true ages of 15 and 16 if asked by the clerks.
