The residents of South 91st street, between National and Lincoln request that the southern half of the block have the following regulated parking:

Monday – Friday, 8am-6pm, 2 hour maximum

Supporting reasons:

- the north half of the block is already regulated in a similar manner
- numerous employees at the office bldg on the corner of 90th & Lincoln park on this section of 91st street during the workday, causing many issues for residents
- they 'hang over' into driveways making it difficult to get in/out of driveways
- they park on both sides of the street also making it difficult to back out (can't easily turn into street without hazard of hitting a parked car, can't easily see oncoming vehicles)
- during the winter the plows cannot keep the street clean of snow
- it's difficult to get larger vehicles (SUVs, pickups etc) down the street to Lincoln in the winter as they don't park as close to the curb so this narrows the street considerably

There are 24 residents (house #s) affected by this issue and 21 signed this petition. Two I could not find at home on several tries and only 1 refused to sign.

We ask that you grant this request and install the signs before winter, if possible.

We, the undersigned, request that the City of West Allis install parking signs to regulate parking on South 91st Street, between Lincoln Ave and National Ave, in the following manner:

Limit parking to 2 hours, between the hours of 8:00 AM and 6:00PM, Monday through Friday.

This would impact only the south end of the block as the north end (beyond 2175/2170) is already posted with similar regulations.
