**RESOLUTION TO AUTHORIZE THE DEPARTMENT OF PUBLIC WORKS TO
ACCEPT AN ALLOCATION OF 2026 RECYCLING GRANT FUNDING FROM
THE DEPARTMENT OF NATURAL RESOURCES FOR \$253,532.54**

WHEREAS, the City of West Allis (“City”) applied for and was awarded a grant in the combined amount of \$253,532.54 to offset the City’s recycling program costs for the fiscal 2026 year; and,

WHEREAS, the City provided the Department of Natural Resources all 2025 recycling accomplishments for single family and 2–4-unit residential housing; and,

WHEREAS, the City agrees to promote and comply with all applicable recycling provisions as outlined in the Wisconsin Statute and Wisconsin Administrative Code; and,

WHEREAS, funds from the awarded grant will assist in the funding of services relating to recycling for the citizens of West Allis; and,

NOW THEREFORE, be it resolved by the Common Council of the City of West Allis as follows:

1. The West Allis Department of Public Works is authorized to accept 2026 recycling grant funding from the Department of Natural Resources.
2. The Director of Public Works is authorized and directed to take any actions necessary to effectuate the intent of this resolution.

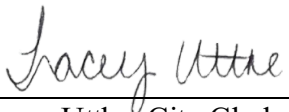

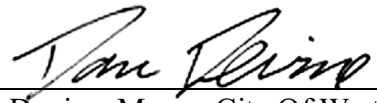
