PETRO MART, INC. (TAX KEY NOS. 442-0635-000 AND 442-0604-000)**

WHEREAS, Gurinder Nagra submitted a Certified Survey Map to combine the existing parcels located at 8404 W. Greenfield Ave. and 1359 S. 84 St. into 1 parcel, submitted by Gurinder Nagra d/b/a State Fair Petro Mart, Inc. (Tax Key Nos. 442-0635-000 and 442-0604-000); and,
