NOW COMES the above named plaintiffs, Tom Holzrichter d/b/a The Best Wood Judge Firewood, Tree & Landscaping Service, by its attorneys, Weiss Law Office, S.C., and as and for a cause of action against the defendant, City of West Allis, hereby alleges and shows to the court, upon information and belief, as follows:

CLAIM I

- 1. That the plaintiff, Tom Holzrichter d/b/a The Best Wood Judge Firewood, Tree & Landscaping Service is an adult male resident of the State of Wisconsin with a presence at 2905 Minot Lane in Waukesha, Wisconsin. That the plaintiff is involved in the business of providing firewood, tree maintenance and landscaping services.
- 2. That the plaintiff business does substantial business in Milwaukee County, Wisconsin at all times material hereto.
- 3. That the defendant, City of West Allis, is a municipal corporation in the State of Wisconsin with its principal place of business located at City Hall, 7525 West Greenfield Avenue, West Allis, WI 53214.
- 4. That on or about December 12, 2000, for good and valuable consideration, the plaintiff entered into a Tree Pruning Contract to provide tree trimming and pruning services to the defendant. That the terms and conditions of the Tree Pruning Contract are attached hereto as Exhibit A and incorporated herein by reference.
- 5. That for good and valuable consideration, the defendant entered into the Tree Pruning Contract with the plaintiff.
- 6. That the plaintiff has adhered to the terms and conditions of the Tree Pruning Contract and has performed the work in a workmanlike manner.
- 7. That the defendant did not comply with the terms and conditions of the Tree Pruning Contract and as such breached the contract.

- 8. That the plaintiff has been damaged by the defendant's breach of the aforementioned Tree Pruning Contract.
- 9. That the plaintiff has made demand upon the defendants for payment of said damages, which was denied.
- 10. That plaintiff has fully complied with Wis. Stats. § 893.80 in all respects as evidenced by a copy of the City of West Allis' denial letter dated July 2, 2003 attached as Exhibit B.

WHEREFORE, for the foregoing reasons, the plaintiff, Tom Holzrichter d/b/a The Best Wood Judge Firewood, Tree & Landscaping Service, hereby demands judgment against the defendant, City of West Allis, for breach of contract in an amount to be determined by the trier of fact, plus costs, disbursements, attorney's fees and for such other further relief as this court deems just and equitable.


