The following is a summary of reported incidents involving licensed businesses, including reported tavern violations and calls for police service during the month of July 2018:

**INCIDENT REPORTS:**

**TAVERN RELATED INCIDENTS NOT REQUIRING INCIDENT REPORT:**

**CALL #18-028664// 18 July 2018 at 2308hrs// Lucky Chance Bar- 6139 W Beloit Rd**  
**NO TAVERN VIOLATION**

**Caller: Tavern Employee**

**TAVERN CHECK:** On 07/18/2018 at approx. 2308 hrs, we responded to 6139 W Beloit Rd, the Lucky Chance bar, on the report of an occupancy violation and people drinking outside. When I arrived, nobody was drinking outside and there were less than 30 people inside the bar. An occupancy sign advised 75 people were allowed. The manager, **Kelly A. Schey w/f [REDACTED]** was advised of the complaint and the tavern was checked for compliance. No problems were found.

**CALL #18-029978// 26 July 2018 at 2340hrs// Johnny Hammers- 6300 W. Lincoln Ave**  
**NO TAVERN VIOLATION**

**Caller: Tavern Employee**

**REQUEST FOR ASSISTANCE:** On 07/26/18 at 2340hrs., officers responded to Johnny Hammers for a problem involving a customer. Bartender Maria R. Farnham f/w [REDACTED] advised an unknown customer, described as a F/W wearing a gray sweatshirt and pants, was drinking other customer's drinks. When she was asked to leave, she grabbed an employee's sports jersey and concealed it under her sweatshirt. Employees eventually retrieved the jersey and told the suspect to leave the business. Maria only wanted the incident documented and have the female warned to stay away from the business. Officers checked the area, but were unable to locate the female in question..

**CASE #18-027333// 11 July 2018 at 0013hrs// Heart Breakers – 9442 W. National Ave Criminal Damage to Property / Misdemeanor / Felony Bail Jumping**

**SUSPICIOUS ACTIVITY:** On 07/11/18, at 0013hrs, Officers responded to Heartbreakers, 9442 W. National Ave., for a report of a male throwing a brick through the window. Investigation revealed that Alex A. Darrah m/w [REDACTED] threw the brick through the front entry door window after getting kicked out. The estimated value of the broken window is approx. \$500 to \$1000.00. Officers located Darrah at McDonalds, 8301 W. Greenfield Ave. at 0200hrs where he was taken into custody for Criminal Damage to Property. CCAP revealed that Darrah has two open cases through Milwaukee County Courts, #2018CT000134 and #2018CF002557. Darrah was conveyed to CJF with the referred charges of Criminal Damage to Property, Felony Bail Jumping and Misdemeanor Bail Jumping. This case is scheduled to be reviewed by the DA's office on 07/13/18 at 0830hrs.

**CASE #18-027413// 11 July 2018 at 2304hrs// Jimmy B's- 7216 W Lincoln Ave Disorderly Conduct**

**DISORDERLY CONDUCT:** On 07/11/18 at 2304hrs, officers responded to Jimmy B's at 7216 W. Lincoln Ave. for a report of 3-4 parties inside of a maroon smaller 4dr sedan (unknown plates), with one of the occupants firing a bb gun at a patron standing outside the bar. The vehicle passed by the business three times before last being seen eastbound on W. Lincoln Ave. The male patron who was outside of the bar during the incident, told the bartender he was hit with a bb, however he left the scene prior to police arrival and was not located. The suspect vehicle was also not located.

**Assault:** On 07-15-18 at 0200 hours, officers responded to the area of 9524 W. Greenfield Ave. for 52 year old male that had been assaulted. Investigation revealed John R. Kegel (M/W [REDACTED]) got into a verbal argument with five unknown white males near the 9600 block of W. Greenfield Ave. During the assault John received multiple small cuts on his face, a possible broken nose and lost consciousness. John was conveyed to the Aurora West Allis Medical Center for medical evaluation. The unknown subjects fled the scene on foot, and were not located. This case is still under investigation.

**DC/Resisting: Officer Mussatti reports :** On 07/25/18 at approx. 1938 hrs., officers were dispatched to Capt'n Nicks, 1503 S. 81 St., for a disorderly female. Investigation revealed Kelly M. Scott, F/W [REDACTED], was being disorderly inside the bar and attempting to break things. Officers made contact with Kelly who was uncooperative. She was arrested and during transport/booking, she continued to be uncooperative and spit inside the squad. She was ultimately booked for DC x2 and Resisting with local court dates of 08/27/18 at 0830 hrs. She was ultimately released.

**CASE #18-030145// 28 July 2018 at 0033hrs// Studz Pub-6833 W National Ave Disorderly Conduct While Armed**

**DC WHILE ARMED:** Officers responded to Studz Pub 6833 W National Ave, for a report of a black male walking eastbound on W National Ave with a knife after he attempted to slash a tire on a County of Milwaukee Transit System Bus. Ronnel Williams, M/B, [REDACTED] was taken into custody in the 6700BLK W National Ave and inside a front pants pocket officers located an approximate 4.5 inch TAC-FLY butterfly knife. It was determined Ronnel was inside Studz Pub when he displayed the knife and was asked to leave the bar, Ronnel then entered a MCTS Bus and a short time later exited and attempted to urinate outside of the bus. Upon officers arrest of Ronnel he admitted to attempting to slash the tire on the bus. Ronnel was highly intoxicated. Ronnel was unable to post bail and was transported to the Milwaukee County Jail. The DA will review this incident on 07/29/18.
