

#### NARRATIVE

Cpl. McNally reports...

#### ARRIVAL

On 08-10-14 at 0148 hrs, officers responded to Big Dog's Sports Bar and Grill, 9427 W. Greenfield Ave. regarding a male subject causing a disturbance and refusing to leave. On arrival, I made contact with the bar manager, Allison M. Schoenfeld, who provided the following statement.

#### STATEMENT - ALLISON M. SCHOENFELD (complainant)

Schoenfeld told me that a black male wearing a camouflage shirt, later identified as Willie T. Broadnax, came into the tavern and immediately began causing a disturbance. Schoenfeld stated Broadnax was upset about money and told her that he had just been robbed. Broadnax asked for money and demanded a ride to Milwaukee. Schoenfeld refused to give Broadnax a ride or money and asked him to leave the tavern. Broadnax told her that he was homeless and had no where to go. Schoenfeld told Broadnax that she would be calling the Police and again requested him to leave the tavern.

Schoenfeld told me that Broadnax eventually left the tavern but then waited on the front steps. Schoenfeld called the WAPD to have Broadnax removed from the area. While waiting for officers to arrive, Broadnax entered the tavern again and began

causing a disturbance. Schoenfeld stated Broadnax was loud and using profanity. Broadnax asked Schoenfeld where the Police were and why they weren't on scene yet. Broadnax asked Schoenfeld if she told the dispatcher that he was black? Broadnax told Schoenfeld that the Police respond faster if she would have told the dispatcher that he was black.

#### STATEMENT - MELISSA L. VAN BECK (witness)

I also made contact with bartender Melissa Van Beck who stated she was the first employee to greet Broadnax. Van Beck stated Broadnax was upset about being homeless. Broadnax demanded a ride to 17/Grant and asked Van Beck for money. Van Beck stated she immediately went to get Schoenfeld based on Broadnax's behavior.

Van Beck provided an identical statement as Schoenfeld, stating Broadnax was loud and disruptive inside the tavern.

# CONTACT WITH WILLIE T. BROADNAX (offender)

Officers made contact with Broadnax inside the tavern. He identified himself with a social security card. Broadnax told me that I owed him \$250 and called me "nigga" several times. I asked him why I owed him \$250? He advised that he was arrested on a West Allis warrant, which he believed he paid in advance. I explained to him to contact the records bureau for information about the warrant. I asked Broadnax how he ended up at Big Dogs. He told me that he was planning to move into a residence on 110th street, but the deal fell through. Broadnax would not explain in further detail and began arguing with officers about a ride. Broadnax told me that he was homeless and demanded a ride to the "ghetto."

While speaking with Broadnax, I detected a strong odor of ingested intoxicants emitting from his breath. Broadnax was argumentative with officers. Broadnax told Officer Schweitzer that he was going to shoot him and was challenging Officer Schweitzer to a fight by stating he was nothing without a badge. I told Broadnax several times that he was free to go and that he needed to leave the area based on the complaint. Broadnax told me that he wasn't going to leave and told me to arrest him. Broadnax was still demanding a ride from officers. I explained to Broadnax that officers were not obligated to give him a courtesy ride into Milwaukee. Broadnax refused to leave the area for the next several minutes. I told Broadnax that if he did not start walking that he would be arrested. Broadnax then turned around and put his hands behind his back and again told me to arrest him because he wasn't leaving. Broadnax told me that if officers left he would wait on the premises until officers responded back. Broadnax told me that Milwaukee Police Department frequently gives him rides if he refuses to leave the property. I explained to him that we were not going to be giving him a ride.

#### CASE DISPOSITION

Broadnax was issued a municipal citation for disorderly conduct. After the booking process, Officer Schweitzer transported Broadnax to 56/National and released him.

#### NARRATIVE

#### CALL FOR SERVICE

On 08/10/14 at approximately 0148 hrs., I responded to Big Dog's Sports Bar and Grill, 9427 W Greenfield Ave for a report of a patron inside the bar causing a disturbance. This male was described as a black male wearing an army jacket.

# CONTACT WITH OFFENDER - WILLIE BROADNAX

Upon my arrival, Cpl McNally and I walked inside the bar and made contact with a black male who matched that description. I asked this black male to walk outside to speak with officers. This black male was later identified as, Willie T Broadnax, M/B, 09/11/67. Willie stated he was out of \$350.00 because a deal fell through. Willie then demanded he needed to get out of "White Allis" and he needed to driven to the "ghetto". I advised Willie the police department is not a taxi service. Willie became angry and began yelling I was a "nigga." I asked Willie to stop calling me that term multiple times. Willie continued to yell at me and stated I should swallow my shotgun and he wanted to shoot me. I asked Willie multiple times to calm down. Willie continued to yell at me, calling me a "racist" and stated, "I was nothing without the badge". Officers advised Willie multiple times he was free to leave. Willie again demanded officers give him a ride to the east city limits. At this time, Cpl McNally placed Willie under arrest for Disorderly Conduct.

I conveyed Willie back to the police station for the booking process.

#### BOOKING

During the booking process, Willie continued to yell at me stating I was a "racists." Willie stated, "I know you want to beat me like they did back in the day." Throughout the booking process I asked Willie multiple times to stop yelling and creating a disturbance inside the booking room. Willie stated, he "served his country and could do whatever he wanted." Willie refused to sign the citation and the WAPD fingerprint card.

#### CONVEYANCE

After the booking process was completed, I conveyed Willie to W National Ave/S 56 St, were he was released. During the conveyance Willie continued to yell at me calling my a "nigga" and "I was a racist piece of shit."
