**RESOLUTION TO CONFIRM AND ADOPT THE REPORT OF THE INTERIM  
CITY ENGINEER CONTAINING THE SCHEDULE OF PROPOSED  
ASSESSMENTS FOR IMPROVEMENT OF VARIOUS STREETS BY CONCRETE  
RECONSTRUCTION**

**WHEREAS,** The Interim City Engineer, pursuant to Preliminary Resolution No. R-2022-0618, adopted on September 20th, 2022, prepared and submitted his report as provided in sec. 66.0703(5) of the Wisconsin Statutes, for the improvement of the streets as hereinafter described; and,

**WHEREAS,** The City Clerk gave due notice that such report was open for inspection at his office and also at the office of the City Engineer, and that all persons interested could appear before the Common Council and be heard concerning the matters contained in the Preliminary Resolution and Report; and,

**WHEREAS,** The Common Council met pursuant to such notice, at the time and place therein named; and having considered all statements and communications concerning the proposed improvements, relating to the matters contained in the City Engineer's report, including the schedule of proposed assessments, the Common Council makes no change in said report.

**NOW THEREFORE,** BE IT RESOLVED By the Common Council of the City of West Allis:

1. The report of the Interim City Engineer, including the schedule of the proposed assessments, for the improvement of W. Washington St. from east of S. 56th St. to S. 60th St., S. 59th St. from W. Beloit Rd. to W. Mobile St., S. 61st St. from north of W. Mineral St. to W. National Ave., W. Pierce St. from S. 58th St. to S. 60th St., W. Orchard St. from S. 108th St. to east of S. 108th St. and W. Beloit Rd. from S. 60th St. to W. Lincoln Ave. by concrete reconstruction be and the same is hereby approved and adopted.
2. The property against which the assessments are proposed is benefited; the assessments shown on the report are true and correct, have been determined on a reasonable basis and are hereby confirmed.
3. The Interim City Engineer is hereby authorized and directed to prepare final plans for the aforesaid area in accordance with the terms of this resolution.
