Dear Mr. Mai:

On August 31, 2010, you applied for a permit for a 11 foot deep by 25 foot wide shelter roof erected on the above referenced property.

Your permit is denied because the shelter roof is in violation of Section 9.21(4)(c)3 of the West Allis Revised Municipal Code. The shelter roof cannot exceed 10 feet. Your shelter roof is 1 foot too deep.

You may appeal this decision to the City of West Allis Common Council. Should you wish to appeal, address a letter to the Honorable Mayor and Common Council stating specifically what you wish to appeal. This letter should be mailed to the City Clerk's Office so that your request can be placed on the agenda of the next Common Council meeting.


