

Officer McNally advised me that he spoke with Gerole L. Csaszar, (f/w, 8/19/67) on scene and advised that she was extremely intoxicated and was unable to give a statement.

STATEMENT BY ASHLEY E. BROCKMAN-VICTIM

Ashley E. Brockman, (f/w, 6/1/89) stated she was inside of Flappers when the offender in this incident, Gerole, "got into" Ashley's sister's, "face" because they had sat down at a table that Gerole claimed to be hers. After one of the bartenders observed they were having a confrontation he walked over and told Gerole she had to leave the bar.

Approx. 1-2 hours late,r Gerole was walking outside past the bar when Ashley was outside. Gerole walked up to Ashley and asked her for a ride home. Ashley explained to Gerole that she lived too far away from where she wanted to go and that she would not be giving her a ride home. At that point, Gerole told Ashley that she, "should be a disgrace to herself". Gerole then pushed Ashley in the right shoulder with her left hand causing Ashley to take a few steps back.

Instead of reacting to being pushed by Gerloe, Ashley then walked back inside of Flappers

During my interaction with Ashley, I detected a strong odor of intoxicants emitting from her breath, she was talking very loud when she was in close proximity to me, and was slurring her words. Ashley also admitted to me, on her own, that she was intoxicated.

Ashley stated she would "definitely" testify in court if need be.

STATEMENT BY ANDREW L. PHELPS-WITNESS/CALLER

STATEMENT BY STEVEN D. MCINTOSH-BARTENDER

Steven D. McIntosh, (m/w, 2/4/86) stated that Gerole had walked into the bar earlier in the night with a lit cigarette, which led Steven to asking her to leave if she wished to smoke. Gerole put the cigarette out and re-entered the bar. At that point Gerole walked over to where Ashley and the group she was with were sitting. Gerole began arguing with the group. Steven then walked up to Gerole and asked her to leave in which she did. At no time did Steven or any other employee of Flappers serve Gerole.

Approx. 45 minutes later Steven said that had come back and was outside of the bar. Shortly after observing this, Officers had arrived on scene. Steven did not observe Gerole push Ashley.

LACK OF CONSENT

At no time did Ashley give Gerole permission to push her nor did any employee of Flappers give her permission to cause a disturbance inside of the bar.

ARREST DECISION

Based on Ashley's statement of her wanting Gerole arrested, Gerole pushing Ashley, and Gerole causing a disturbance in the bar earlier in the night, Gerole was taken into custody for disorderly conduct.

TRANSPORT/BOOKING PROCESS

After Gerole was searched by a West Milwaukee Police Department Officer, I placed Gerole into the back of my squad and transported her to WAPD for the booking process.

While at the station, Gerole was booked, mugged, printed, and cited. Gerole was placed in a cell until morning in which she could contact someone who lives in town for a transport.

Gerole was booked under WAPD Booking #: 2013005047 and WAPD #: A-252556. Gerole was issued municipal citation #: M130050471 for disorderly conduct and given a local court date of 12/2/13 at the West Allis Municipal Court.

MIRANDIZED STATEMENT

On 10/27/13 at approx. 0253hrs, while in Interview Room B of the West Allis Police Department, I read Gerole her Miranda Warnings off Departmental Directive 42.016. Gerole agreed to speak with me regarding this incident. This interview was audio recorded on an Olympus DS-2200 Digital Voice Recorder and saved on a departmental media card (P10-5) and stored in the Technical and Forensics Bureau. DEFENDANT'S statement here is paraphrased for this report.

Gerole stated that she walked into the bar and sat there for one hour to warm herself up and did not drink anything. She then left the bar for 2 minutes and came back inside and that is when "Amazon Woman" threw a drink at her. Gerole could not describe "Amazon Woman" but stated she was big boned and did not know

Gerole then advised that she never went back inside of the bar and that when she was outside looking for a ride home. That is when she was being bullied by a group of women and felt bad because she could not defend herself. Gerole then asked the bartender to call the police.

Gerole denied ever pushing anyone at anytime.

PERSONAL OBSERVATIONS

During my contact with Gerole, her statements and comments did not make much sense. I detected a very strong odor of intoxicants emitting from her breath. Her speech was very thick and slurred.

CASE DISPOSITION

Gerole was arrested for pushing Ashley in the shoulder. Ashley was adamant that she would testify in court if need be. Both Ashley and Gerole were intoxicated during tonight's incident.

NARRATIVE

Officer Molthen reports:

INITIAL CALL

On 10/27/13 at approximately 0127 hrs, I responded to Flappers Tavern 7527 W. Becher St in regards to a female pushing another female. Upon arrival, I spoke with Andrew L. Phelps (M/W, 07/23/86), about this incident. Phelps was working in a security capacity at the bar.

STATEMENT OF ANDREW L. PHELPS

I spoke with Andrew who stated an intoxicated female, later identified as Gerole L. Csaszar (F/W, 08/19/67), began screaming and causing a disturbance inside the bar about two females taking her table. Andrew told me he asked Gerole to leave, to which she complied. Approximately 45 minutes later, Gerole came back, and was began causing a disturbance outside the bar.

Andrew went outside and observed Gerole push the female she had got into an argument with earlier. Both females were in each other faces, yelling at each other. Andrew told me another female stepped in and took the female Gerole was arguing with into the bar. A short time later police arrived on scene.
