AB506 SHARED REVENUE FUNDING LEVEL

OPPOSE, because the bill would establish shared revenue funding levels separately from the entire state budget which should be considered as part of the total budget. In addition, the funding level is at the same level and should be modified to include a modest increase.

AB507 LEVY LIMITS

OPPOSE, because the bill would establish a levy limit separate from other municipal budget policies, which should be considered as part of the total package. In addition, the levy limit is at 2%, which should be increased to 3-4% for an older, mature city like West Allis.

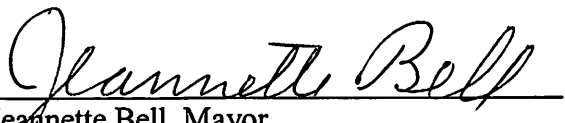
