

**CITY OF WEST ALLIS
RESOLUTION R-2022-0486**

**COMMENDATION FOR MEMBERS OF THE WEST ALLIS POLICE AND FIRE
DEPARTMENTS**

WHEREAS, On Sunday, June 19, 2022, at approximately 1:00 a.m., members of the West Allis Police and Fire Departments were dispatched to a fire at a mobile home park, and:

WHEREAS, West Allis dispatchers Milissa Schreiber, Keswana Jackson, and Deborah Brandt were able to process the 911 calls and alert the West Allis Police and Fire Departments in less than one minute, and;

WHEREAS, West Allis Police Officers Ryan Schultz, Jordan Cooper, Caleb Hoff, and Ryan Stuetgen arrived first on scene and West Allis Fire Department's Engine 63 - Lt. Dan Rohde Fire Fighters Jake Levenhagen, Tom Marquardt, and Deonte Pettis arrived on scene in less than five minutes from the time of dispatch, and;

WHEREAS, Engine 63 immediately began simultaneous fire suppression and victim rescue activities and West Allis police officers were able to locate the trapped child through a bedroom window and attempted to rescue the child, and;

WHEREAS, West Allis Fire Engine 63's Lt. Dan Rohde was able to enter the bedroom through a window by himself and locate, remove and hand the child to West Allis Police officers outside of the home, and;

WHEREAS, the child's transport to the hospital began less than eight minutes after the arrival of Engine 63 and the child was admitted to the hospital for significant injuries sustained in the fire.

NOW THEREFORE, Lt. Dan Rohde, Fire Fighters Jake Levenhagen, Tom Marquardt, and Deonte Pettis; West Allis Police Officers Ryan Schultz, Jordan Cooper, Caleb Hoff, and Ryan Stuetgen, and dispatchers Melissa Schreiber, Keswana Jackson, and Deborah Brandt are recognized with this life-saving commendation for their quick actions and teamwork that ultimately led to the successful rescue of the child who is expected to make a full recovery.
