The following is a summary of reported incidents involving licensed businesses, including reported tavern violations and calls for police service during the month of April.

Incident reports:

Case #15-14478, 04/06/2015, 2324 hrs: 8812 W. Greenfield Av – Stallis Palace

On 04/06/2015, Officers responded to the Stallis Palace for a male detained by people regarding a fight on the sidewalk. Investigation revealed one party hit another party in the face with a closed fist. This party was uncooperative with police, arrested for Battery and given a municipal citation. The party had been drinking alcohol inside the tavern, was highly intoxicated and had been kicked out of the tavern by the manager.

Case #15-14787, 04/09/2015, 1644 hrs: 2300 S. 108 St - Lynch's Tavern

On 04/09/2015, Officers responded to Lynch's Tavern after people reported several males wrestling outside. Investigation revealed that inside the bar, two unknown males approached a patron and attempted to start an argument. These highly intoxicated males were also being derogatory and disrespectful toward the bartender. One party stated he pushed the group outside in an attempt to break up the fight. While doing this, another patron fell down the stairs. The parties continued the fight until a patron pulled one of the males away. The males then left the area. The bartender stated anything that happened, happened outside. WAFD was called to assess the party who fell down the stairs. She advised she would have a friend transport her to the hospital.

Call #15-15108, 04/11/2015, 1752 hrs: 5906 W. Burnham St – Drunken Duck

On 04/11/2015, Officers responded to Drunken Duck for an anonymous report that the bartender, Hector E. Guillermo, was bartending without a license. Contact was made at the bar with Hector, who advised he had to surrender his license due to a recent investigation. Hector had another employee on scene who provided a valid bartending license. There were no violations.

Call #15-16179, 04/18/2015, 0201 hrs: 6500 W. Greenfield Av. - 6500 Bar

On 04/18/2015, while an Officer was on patrol, he observed a male exit the 6500 Bar and begin to urinate on the west side of the building. He was uncooperative and began to swear at Officers, denying the wet bushes. He was arrested, booked and cited for Disorderly Conduct.

Call #15-17580, 04/27/2015, 0114 hrs: 1641 S 68 St – Dog House

On 04/27/2015, Officers were out with a party sleeping in a vehicle in the 1600 block of s. 68 St. While Officers were investigating the incident, an intoxicated party exited the Dog House. He grew increasingly disruptive with Officers and obstructed their investigation. He was arrested, booked and cited for Obstructing.
