Schlossmann's Honda, 3450 S. 108<sup>th</sup> St. is seeking a Special Use Amendment to make improvements to both their building and site so as to better conform to corporate Honda's design standards. Phase 1 of the building improvements involve the construction of a new Service Building area, and Phase 2 includes building façade modifications and interior renovations to the Service Center and Showroom.
