Attorney Roger Pyzyk, 10701 W. National Ave., representing Laura Cagle of The Learning Years, stated that the condition of the building is better now than when it was vacant. He addressed circumstances relative to some items not being completed on a timely basis, and the plans of UW-Extension. Mr. Pyzyk described Ms. Cagle's investment, meetings with inspectors, communication factors, and the responsibility of the School Board. He asked that the permit not be revoked for The Learning Years, and that 114 families use the services of The Learning Years.
