Resolution relative to an agreement between the City of West Allis and the West Allis/West Milwaukee Family Resource Center for the provision of the Brighter Futures programs and services.

WHEREAS, the West Allis Police Department, West Allis Health Department and the West Allis-West Milwaukee Family Resource Center have formed a partnership to seek grant funds from the Brighter Futures program.

WHEREAS, the partnership has been successful in obtaining a grant in the amount of \$75,000 from Brighter Futures.

WHEREAS, a subgrantee-agreement has been drafted between the City of West Allis and the West Allis-West Milwaukee Family Resource Center for the transfer of the Center's share of the awarded funds.

BE IT RESOLVED by the Common Council of the City of West Allis that an agreement between the City of West Allis and the West Allis-West Milwaukee Family Resource Center for the distribution of grant funds, a copy of which agreement is attached hereto and made part hereof, is hereby approved.

NOW, THEREFORE, BE IT FURTHER RESOLVED that the Common Council of the City of West Allis hereby authorizes and directs the City Health Commissioner to sign the aforesaid Contract Agreement.

Brighter Futures Subgrantee Agreement

THIS AGREEMENT, entered into by and between West Allis-West Milwaukee Family Resource Center, (hereinafter referred to as the "CONTRACTOR"), and the City of West Allis, a municipal corporation of the State of Wisconsin (hereinafter referred to as the "CITY").

NOW, THEREFORE, the parties hereto do mutually agree as follows:

- I. RETENTION OF SERVICES AND REQUIREMENTS. The CITY hereby agrees to engage the CONTRACTOR and the CONTRACTOR hereby agrees to personally perform, as an independent contractor and not as an employee of the CITY, the services hereinafter set forth, all in accordance with the terms and conditions of this Contract. CONTRACTOR, agrees time is of the essence and will meet all deadlines, any schedules as herein set forth, and is required to:
 - A.) Provide all services related to the Watch as We Grow program to the West Allis Community.
 - B.) Submit all required reports to Community Advocates, the grantor of the Brighter Futures Initiative.
 - C.) Participate and collaborate on the preparation and submission of annual grant renewal applications to Community Advocates.

Amount and Method of Payment

The City agrees to reimburse the Contractor up to \$30,000 for Watch as We Grow program services. This amount may be modified by agreement between the parties. Receipt of an invoice from the Contractor will be submitted to the City of West Allis Finance Division for payment.

Term of Contract
