Resolution Constituting a Relocation Order, Pursuant to Secs. 62.22 and 32.05(1) of the Wisconsin Statutes, for the Laying Out, Relocation and Improvement of the Intersection of West National Avenue and West Oklahoma Avenue to Root River Parkway.

BE IT RESOLVED by the Common Council of the City of West Allis as follows:

1. That it is necessary and in the public interest that the intersection of West National Avenue and West Oklahoma Avenue to Root River Parkway, be laid out, relocated and improved (the "Project").
2. That the Relocation Order for the Project, which is annexed to this Resolution as Exhibit "A" and made a part hereof, be and is hereby approved.
3. That this Resolution constitutes a Relocation Order in accordance with Sec. 32.05(1) of the Wisconsin Statutes for the purpose of the Project and is also a determination of necessity for that Project, in accordance with Secs. 62.22 and 32.07(2) of the Wisconsin Statutes.
4. That a certified copy of this Resolution be filed with the Milwaukee County Clerk within twenty (20) days of its adoption and final approval.

Description of Termini of Project

SITE LOCATION

Just Easterly of Intersection Corner
of West National Avenue and West Oklahoma Avenue:

S55° 35' 30" W to S34° 24' 30" E

To properly establish, lay out, widen, enlarge, extend, construct, reconstruct, improve, or maintain a portion of the highway designated above, it is necessary to relocate or change and acquire certain lands or interests in lands as shown on the right of way plat for the above project.

To effect this change, pursuant to authority granted under Sections 62.22 and 32.05(1), Wisconsin Statutes, the City of West Allis orders that:

1. The said road is laid out and established to the lines and widths as shown on the plat.
2. The required lands or interests in lands as shown on the plat shall be acquired by the City of West Allis.
3. This order supersedes and amends any previous order issued by the the City of West Allis.
