NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN that the Common Council of the City of Greenfield will hold a public hearing in the Common Council Chambers at the Greenfield City Hall, 7325 West Forest Home Avenue, Greenfield, Wisconsin, on <u>Tuesday</u>, the 23rd day of September 2008 at 6:15 p.m. to solicit comments on proposed floodplain ordinance and map revisions that are required by state and federal law. These revisions govern development in mapped floodplain areas.

The proposed regulations are intended to protect life, health and property in floodplain areas and will govern uses permitted in mapped floodplains. Activities such as dredging, filling, excavating and construction of buildings are generally allowed, but may be restricted according to which flood zone the property is in.

NOTICE IS HEREBY FURTHER GIVEN that the proposed floodplain ordinance is open for review and inspection in the Engineering Division, Greenfield City Hall, Room 203, 7325 West Forest Home Avenue, Greenfield, Wisconsin, from Monday through Friday between the hours of 8:00 a.m. and 5:00 p.m. and will be so continued for the space of nineteen (19) days after the date of publication of this notice.

All persons interested, their agents or attorneys, are invited to attend this hearing and be heard. Written comments may be submitted to the City Engineer, 7325 West Forest Home Avenue, Greenfield, Wisconsin 53220.
