Upon deliberation and consideration of the evidence presented at the hearing held on September 1, 2009, the Committee finds:

FINDINGS OF FACT:


1. That the allegations in the complaint were admitted by Jeffrey Farrington and are true;
2. That the conduct of Jeffrey Farrington described in the complaint substantially relates to the alcohol beverage licensed activity contrary to Wis. Stat. § 125.04 (a)(1);
3. That in particular, Farrington's third operating while intoxicated conviction in April 2009, is contrary to Wis. Stat. § 125.04 (a)(1).

CONCLUSIONS OF LAW:

1. That the evidence submitted at the hearing constitutes a sufficient basis to not renew the bartender's license of Jeffrey Farrington.

Therefore, the License and Health Committee recommends to the Common Council of the City of West Allis that the Bartender's License of Jeffrey Farrington not be renewed.
