Re: Request to approve use of 2009 FEMA Grant and City Match

In early August, I received notification that we had written a successful Federal Emergency Management Agency (FEMA) Assistance to Firefighters Grant (AFG). Our city has been awarded \$11,000 to enhance public safety through the distribution of smoke detectors. The grant was written to replace diminishing funding through the Community Development Block Grant program for a similar use. The city's obligation toward the program is 20%, or in this case, \$2,200.

On August 20, 2009, the West Allis Board of Police and Fire Commissioners approved my request to accept and utilize the funds for their appropriate purposes, contingent upon your Council's approval of the matching funds.

I've attached documentation explaining the grant, and providing verification of the PFC approval.

With this communication, I am asking your Council's approval for acceptance of the grant, and the City's 20% obligation.

Re: 2009 Assistance to Firefighters Grant – Fire Prevention

On August 7, 2009, we received notification that the City of West Allis was awarded \$11,000.00 through the 2008 Assistance to Firefighters Grant – Fire Prevention and Safety Grant Program. The award is to further our current smoke alarm distribution program. The City of West Allis is required to provide a 20% match of the award. The grant will provide \$8,800.00 and the City will provide \$2,200.00 for this program.

The program will formalize our current program to include smoke alarm distribution to elderly and low-income residents in West Allis. The program narrows the distribution further to single-family and duplex units. The main component is the completion of a community fire risk assessment. The neighborhoods chosen will be in the 52 quarter sections and 63 census tract block groups within the City of West Allis. This will give us census tract information to relate back to regarding income, ethnicity and housing types. We plan on delivering this program to 2,000 homes, which represents 10% of the 20,455 single-family and duplex units within West Allis. We expect to deliver over 500 smoke alarms to homes in need of smoke alarms and some 500 smoke alarm batteries to homes with non-working smoke alarms. Each participating home will receive fire safety information.

The program will end six months after the initial delivery with a follow-up canvass of the homes receiving smoke alarms to see if they are still in working condition and to check to see if any other fire safety information supplied has been incorporated (fire safety plan developed and practiced).

The program will take about nine months to implement, evaluate and provide a final report on data collected.

Re: Request to approve use of 2008 AFG Excess Funds

On August 20, 2009, the West Allis Board of Police and Fire Commissioners approved our purchase of communication equipment that was made possible by Federal Emergency Management Agency (FEMA) Assistance to Firefighters Grant (AFG). Your Council approved the 20% matching funds (\$12,960) and grant expense in January of 2009, and we have been working with vendors and manufacturers to assure that we were purchasing the newest version of this equipment to best utilize city funding.

We were fortunate to be able to realize considerable savings through competitive bidding that provided \$22,965 in excess grant funds. According to FEMA policy, grant recipients can use excess funds to purchase necessary equipment in compliance with a set of parameters explained in the grant documentation. With this in mind, we've examined ways to obtain essential equipment while decreasing the financial burden on our 2010 budget.

I have attached documentation explaining the grant parameters and our intended use of the excess funds. Even with the use of these funds, we will still spend \$1,632 less than the original contribution of \$12,960 that was approved in January.

With this communication, I am asking your Council's approval (if necessary) to apply a portion of the City's 20% grant obligation from the original FEMA AFG grant, for the equipment outlined in the attached documentation.



Re: 2008 Fire Act Grant Excess Funds

On November 4, 2008, the City of West Allis received notice that it was awarded the 2008 Assistance to Firefighters Grant for SCBA communication equipment in the amount of \$64,800.00. We recently received and accepted the competitive bid for the communication equipment in the amount of \$41,835.00. This has resulted in funds remaining (\$22,965.00) after completing the grant obligations. The Department of Homeland Security has developed a policy for use of excess funds (Appendix 7 – Excess Funds is attached). They have identified three options for the use of excess funds:

- (1) Grantees may use the greater of 1 percent of their award amount or \$5,000 to continue, or expand, the activities for which they receive the award. Grantees may use funds to purchase other eligible items (subject to the above limitation).
- (2) Grantees may use excess funds to create, or expand, a fire or injury prevention program. Excess funds above the amounts discussed in paragraph (1) above must be used for fire or injury prevention activities or returned to DHS (See option 3 below)
- (3) Grantees may return excess funds to DHS.

The West Allis Fire Department command staff met to discuss the best possible option for the City of West Allis. It was determined that a combination of all three options be utilized as follows:

- (1) The purchase of 3 extrication/heavy rescue airbags in the amount of \$2,730.00. Purchase related regulators and hoses for the airbags in the amount of \$1,110.00. Purchase of extrication/heavy rescue cribbing in the amount of \$962.50. The total amount expended will be \$4,802.50 (City match will be \$ 960.50).
- (2) Submit a grant amendment for expansion of a current fire prevention activity. This would be the expansion of the current smoke alarm distribution that the fire department provides to include 90 Lifetone HL smoke alarms for deaf and hard-of-hearing in the City of West Allis. The estimated request would be for \$10,000.00 (City match would be \$2,000).
- (3) The remaining excess funds, \$ 8,162.00, would be returned to the federal government. The City of West Allis unexpended match would be \$1,632.00.

Appendix 7. Excess Funds

Occasionally, due to successful competitive bid processes, some grantees have funds remaining after the completion of the obligations outlined above. Fire department grantees that complete the approved scope of work prior to the end of the performance period, and still have grant funds available, have three options for the use of the excess funds:

- (1) Grantees may use the greater of 1 percent of their award amount or \$5,000 to continue, or expand, the activities for which they received the award. For example, if a grantee has funds remaining after completion of the activities listed in their grant agreement, the grantee may use excess funds (subject to the above limitation) to purchase other eligible items without seeking DHS approval.
- (2) Grantees may use excess funds to create, or expand, a fire or injury prevention program. Excess funds above the amounts discussed in paragraph (1) above must be used for fire or injury prevention activities or returned to DHS [See option (3) below]. In order to use excess funds for fire or injury prevention activities, a grantee must submit an amendment to its grant. The amendment request should explain the following:
 - i) fire or injury prevention efforts currently underway in your organization;
 - ii) where the use of excess funds would fit within your existing efforts, if applicable;
 - iii) what is the fire or injury problem that you are trying to address with these funds;
 - iv) the target audience for your fire or injury prevention project(s), and how this audience was identified;
 - v) how you will implement/deliver your project(s); and
 - vi) how you will evaluate the effectiveness of the requested fire or injury prevention project(s).
- (3) Grantees may return excess funds to DHS. To exercise this option, a grantee must close out its award and state in the final performance report that the remaining funds are not necessary for the fulfillment of grant obligations. The grantee must also indicate that it understands that the funds will be deobligated and unavailable for

future expenses. Deobligation of excess funds will decrease the Federal portion of the grant and the amount of the grantee's match.

Fire department grantees that complete the approved scope of work prior to the end of the performance period, and still have grant funds available, may also use excess funds in a combination of activities from options (1) and (2). Nonaffiliated EMS organizations that have excess funds may exercise the same options for use of excess funds as that of a fire department, however, EMS organizations are restricted to uses that only involve injury prevention. EMS organizations may not expend grant funds for fire prevention activities.
