Discussion relative to licensing of amusement devices pursuant to section 9.08 of the Revised Municipal Code.

Ald. Czaplewski asked Ms. Schultz to provide an explanation for the addition of the certification statement on the application for Amusement Tags. Ms. Schultz informed the Committee that it was brought to her attention that gambling devices erroneously received amusement tags in the past. She stated that the certification would clarify to the Clerk's Office that the machines being licensed were in fact amusement devices. Ms. Schultz stated that no complaints or concerns were relayed to the Clerk's Office regarding the revised form.

Ralph Fleege described his concerns relative to signing off on the amusement device application because of the potential that the machines could be used for gambling. He provided the Committee an explanation of how his business reports to the State.

The Committee asked for further information from Mr. Fleege, and the Committee will seek a legal opinion from the City Attorney.

Ald. Barczak moved that the Clerk's Office accept applications that are unsigned or that have the certification stricken unless the City Attorney advises otherwise. Seconded by Ald. Weigel and carried by the following vote:
