WHEREAS, the City of West Allis currently employs Mr. Paul M. Ziehler in the position of City Administrative Officer, Director of Administration & Finance, Clerk/Treasurer under the terms of the Employment Contract dated July 24, 1980, as amended on January 26, 1989 and May 27, 2003; and,

WHEREAS, said Employment Contract includes Paragraph G on Page 4, on the subject of the Wisconsin Retirement Fund; and,

WHEREAS, said provision needs to be amended to bring it into compliance with new, similar Wisconsin State Law provisions on employee/employer cost sharing provisions of the Wisconsin Retirement Fund.

NOW, THEREFORE, it is hereby agreed by and between the City of West Allis and Mr. Paul M. Ziehler that the wording of Paragraph G, on Page 4 (Wisconsin Retirement Fund), be deleted and replaced with the following wording:

"The City and Mr. Ziehler shall pay their respective employer and employee shares to the Wisconsin Retirement Fund as specified by State law."

BE IT FURTHER AGREED that new wording be added as Paragraph M, on Page 4, as follows:

"M. <u>Length of Service Allowance</u>. An annual Length of Service Allowance will be paid during the last two weeks of December, of ten dollars (\$10.00) times the number of years of full-time service completed with the City on December 15th, if employed at that time."
