Dear Council Members,

As part of the annual liquor license renewal process, the Department of Building Inspection and Neighborhood Services performs inspections of a business's compliance with the Zoning Code and Plumbing Code. This communication is in regards to the 2015 and 2016 liquor license renewal inspections performed for Vani's Kitchen, located at 10535 W. Greenfield Avenue.

The zoning compliance for the property has been in substantial compliance in both 2015 and 2016. Those inspections were approved on July 7, 2015, and July 5, 2016, respectively. There were no issues noted with either year's zoning inspection.

The plumbing inspection, however, was not approved for either year. For the 2015-16 license year, the plumbing inspection on July 7th revealed 2 code deficiencies. As of the date of this letter, one of those items has been resolved, but the other is still deficient. For the 2016-17 license year, the plumbing inspection performed on June 6th revealed two additional code deficiencies. As of the date of this letter, neither item has been resolved. All three items remaining do not require a permit or a licensed plumber to fix, however they do have to be fixed in accordance with the State of Wisconsin Plumbing Code. Once these three items are resolved, the owner is required to schedule a time for the plumbing inspector to come back to the property and inspect the work. The inspector's Correction Notices to the license holder are included for your reference.
