Mattice (m/b, [REDACTED]). Encino also picked up a stool and tried to assault Mattice, who defended himself with a stool. Mattice was able to get Encino to the ground, and Encino left the bar shortly thereafter. Officers located Encino in the area and arrested him for DC and Criminal Damage to Property as a stool was damaged during the altercation. The case will be reviewed at the District Attorney's Office on 09/01/20 at 0830hrs.


