**RESOLUTION TO APPROVE THE BID OF CENTURY TRAFFIC, LLC FOR
PAVEMENT MARKING AT VARIOUS LOCATIONS IN THE CITY OF WEST
ALLIS IN THE AMOUNT OF \$284,098**

WHEREAS, the Board of Public Works duly advertised for bids for the furnishing of certain materials and the performance of all work required for the improvements in a certain area as described below, and the bids received were reasonable; and

WHEREAS, it is in the best interests of the City that the bid of Century Traffic, LLC for 2026 Project No. 18 be accepted.

NOW THEREFORE, be it resolved by the Common Council of the City Of West Allis that the bid of Century Traffic, LLC for 2026 Project No. 18 for the installation of pavement marking at various locations throughout the city of West Allis for a sum of \$284,098 be accepted.

BE IT FURTHER RESOLVED that the proper City officers are authorized and directed to enter into contractual relations with said contractor for the performance of said work, in accordance with the prices submitted in their proposal and with the specifications of the City of West Allis, and that all other bids received for same be rejected.

BE IT FURTHER RESOLVED that said improvements be installed with funding by Street Bond Funds and Capital Projects cash reserves.

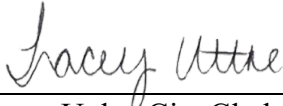

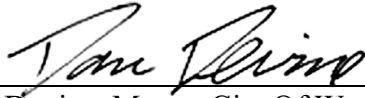
