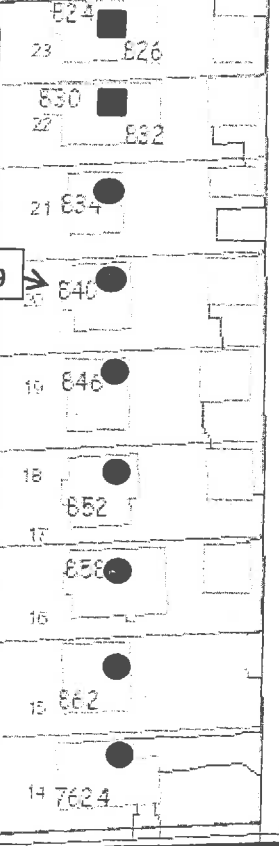
**KOPPERUD PARK
