The City of West Allis Common Council approved the Special Events Permit for the following entity at the June 25, 2020, Council meeting:

(2020- 0385) 2020-2021 Combination Class B Special Event Permit application no. 4 of Field Trip LLC, Kristine Budiak, Agent, d/b/a Paulie's Field Trip, 1430 S. 81 St., for premises extension due to COVID, may through October 2020, (all of Paulie's Field Trip parking lot and the parking lot north of Field Trip, with tent, food, and outdoor music) First (1<sup>st</sup>) permit application for 2020-2021 license year.

This Permit was approved with the following conditions:

- 1) The above listed Permit and operation of the event(s) would be issued subject to approval by City Departments (i.e. Building Inspection Department, Fire Department, Health Department, etc.).
- 2) That the establishment, operators, and agent subject to this Permit maintain their premise and events in conformity with their Site, Landscaping, and Architectural Plans that were approved on May 27, 2020.
- 3) That the Permit will be valid from the date of approval through September 7<sup>th</sup>, 2020 (Labor Day) AND thereafter on Fridays and Saturdays only until October 31, 2020. Those days are:
  - a. September 11 through 12 (Friday and Saturday)
  - b. September 18 through 19 (Friday and Saturday)
  - c. September 25 through 26 (Friday and Saturday)
  - d. October 2 through 3 (Friday and Saturday)
  - e. October 9 through 10 (Friday and Saturday)
  - f. October 16 through 17 (Friday and Saturday)
  - g. October 23 through 24 (Friday and Saturday)
  - h. October 30 through 31 (Friday and Saturday)

These Permits will automatically expire on November 1, 2020, at 12:01 AM.

- 4) That, subject to condition 3, the hours of operation shall be:
  - a. Sunday through Thursday- permitted locations may operate from 10:00 AM to 9:00 PM.
  - b. Friday and Saturday- permitted locations may operate from 10:00 AM to 10:00 PM.
- 5) Sound systems or noise projection shall be in compliance with local ordinance and shall not cause a disturbance of the surrounding community. Bands playing at the Paulie's Field Trip location shall be 3 members or less and there shall be only one band playing at a time between the Paulie's Field Trip location and Paulie's Pub location.
- 6) The maximum occupancy at the Paulie's Field Trip shall remain at 73 persons in total for both the indoor and outdoor premises areas.
- 7) The premises contemplated in this Permits must maintain appropriate daily clean up, maintenance, and garbage or refuse control as required to maintain a clean, orderly, safe, and pest/rodent free condition.
- 8) That City staff will review the use and compliance with this Special Event Permit and accompanying conditions every thirty (30) days and may provide updates to the Common Council or enforcement mechanisms as needed.
