

**CITY OF WEST ALLIS
RESOLUTION R-2024-0028**

**RESOLUTION AUTHORIZING THE HEALTH DEPARTMENT TO ACCEPT AND
EXPEND FUNDING FROM THE NATIONAL ENVIRONMENTAL HEALTH
ASSOCIATION (NEHA) AND US FOOD & DRUG ADMINISTRATION (FDA) TO
ADDRESS RETAIL FOOD STANDARDS**

WHEREAS, the FDA has made available grant funding to collect, prepare, and submit documents to meet retail food standards;

WHEREAS, the City of West Allis applied and is being awarded \$17,500.00 by the NEHA-FDA to accomplish the collection, preparation, and submission of food retail standards in 2024;

WHEREAS, the West Allis Health Department serves as the agency responsible for administering these funds; and,

WHEREAS, the 2024 budget did not include an appropriation for the NEHA-FDA grant funding;

NOW THEREFORE, BE IT RESOLVED that the Common Council of the City of West Allis:

1. Authorizes the West Allis Health Department to accept CDC NEARS Explorer Program grant funding and
2. Appropriates and amends the 2024 City Budget to allow for the expenditure of CDC NEARS Explorer Program grant funding as allowed in the grant program; and
3. That the Health Commissioner is hereby authorized and directed to take any and all other actions deemed necessary to effectuate the intent of this Resolution.
