Arthur Ave. and S. 81st St. from 300' South of W. Lincoln Ave. to W. Arthur Ave. in the City of West Allis, in the amount of \$1,080,415.00.

- S. 81st Street: 300' South of W. Lincoln Avenue to W. Arthur Avenue




