The following is a summary of reported incidents involving licensed businesses, including reported tavern violations and calls for police service during the month of August.

Incident reports:

Case #15-32027, 07/22/2015, 2258 hrs: 8824 W. Becher St – Walleye Saloon (Late reporting)

On 07/22/2015, Officers responded to the Walleye Saloon for a trouble call. Investigation revealed a party caused a disturbance in the tavern and took another patron's phone. Both parties involved were reported to be highly intoxicated. The offending party fled prior to Officer's arrival. He later came to the Police Department and returned the phone. He was cited for Disorderly Conduct.

Case #15-32531, 07/26/2015, 2320 hrs: 5826 W. Burnham St – Rockstar Saloon (Late reporting)

On 07/26/2015, Officers responded to Rockstar Saloon for a male who had fallen. Investigation revealed one party stepped outside of the bar to smoke a cigarette and another party came out of the bar, punched him and left the scene prior to Officer's arrival.

Case #15-33349, 07/31/2015, 2320 hrs: 5826 W. Burnham St – Rockstar Saloon (Late Reporting)

On 07/31/2015, Officers responded to Rockstar Saloon for a report of an unknown male, who was intoxicated and refusing to leave the bar. Upon arrival, the party was now standing in front of the Drunken Duck, attempting to get into the bar. Security felt he was too intoxicated and

would not allow him inside of the business. The party lied to Officers regarding his identity. He was subsequently arrested for Disorderly Conduct and Obstructing an Officer.

Case #15-34121, 08/05/2015, 0207 hrs: 6108 W. Burnham St – Fiddler’s Green

On 08/05/2015, Officers responded to Fiddlers Green Tavern for a patron that would not leave the tavern. The bartender stated the female party came into the bar at 0030 hours and ordered a double Bacardi Rum with water and an additional shot. She refused to leave at closing time. Officers located her stumbling through the parking lot and showed signs of high intoxication, in violation of her bail for an OWI – 2nd Offense. She was arrested and charged with Bail Jumping at the Milwaukee County District Attorney’s Office.

Case #15-35082, 08/09/2015, 0149 hrs: 9440 W. National Av – Heartbreakers

On 08/09/2015, Officers responded to Heartbreakers for a possible weapons call. The offender made threats to staff and indicated he was going to retrieve a firearm. He was highly intoxicated and kicked out of the bar. Security would not allow him to reenter. A firearm was not located during a consent search of the offender’s vehicle. He was arrested for disorderly conduct and was later released.

Case #15-37809, 08/23/2015, 1812 hrs: 1309 S. 60 St – Remedy

On 08/23/2015, Officers responded to Remedy Bar for a fight in progress. The caller reported a male had used a stun gun on another male during an altercation. Both parties fled the scene. Investigation revealed the male party consumed alcohol and took his prescription medication (Oxycodone) prior to driving to the Remedy Bar with his 2 year old grandson in the vehicle. At the bar, he engaged in a physical altercation with another male because of monies owed. The male party stunned the other male several times. He then drove his grandson home. He was arrested for OWI (1st offense w/a passenger under the age of 16), Battery – Use of Weapon, Possession of Electric Weapon and Carrying a Concealed Weapon.

Case #15-38292, 08/26/2015, 2347 hrs: 7731 W. Becher St – Boosters

On 08/26/2015, Officers responded to Boosters for a disorderly conduct incident and vandalism. While reviewing the video surveillance, it revealed the incident started at Boosters and eventually, one of the male parties walked outside and broke a vehicle window. While at Boosters, the bartender was found to be bartending without a valid bartending license. The owner was not on scene when Officers arrived. With no licensed bartender on site, the manager responded to the bar. The bartender and the owner were mailed citations.

Case #15-38788, 08/30/2015, 0121 hrs: 1902 S. 68 St – The Drunk Uncle

On 08/30/2015, Officers responded to The Drunk Uncle for a trouble call. A boyfriend saw his girlfriend kiss another guy inside the tabern. When they were outside, an argument ensued. The boyfriend took her cell phone and smashed it. He then pushed her to the ground and needed to

be restrained by multiple people. He was arrested from Criminal Damage to property and Disorderly conduct/Domestic Violence related. He was conveyed to the Milwaukee County Jail.
